DUTIES:

This position will provide support to school districts, charter schools, and education service cooperatives through monitoring and technical assistance activities to improve results for children with disabilities and ensure compliance with state and federal regulations. Additionally, this individual will participate in due process procedures resulting from complaints or pre-hearings stemming from disputes over the implementation of Part B of the Individuals with Disabilities Education Act (IDEA) and will perform other duties as assigned.

PREFERRED REQUIREMENTS:

Possess a current or be eligible for a standard Arkansas educator's license; or hold an expired standard Arkansas educator's license; or a standard out-of-state license and is eligible for a one-year provisional license and a standard license in Arkansas. A Master's degree in special education/educational administration or a related field; a minimum of five years teaching experience in the public schools; some in-state travel is required.

SPECIAL APPLICATION INFORMATION:

Only a completed application with work history is accepted. The work history section of the application must be complete. We do not accept resumes in lieu of completing this section.

MINIMUM QUALIFICATIONS:

The formal education equivalent of a bachelor's degree in public administration, educational administration, education or a related field; plus five years of experience in education, public school administration, or related field.

Must possess a valid Arkansas driver's license. Additional requirements determined by the agency for recruiting purposes require review and approval by the Office of Personnel Management. Other job related education and/or experience may be substituted for all or part of these basic requirements, except for certification or licensure requirements, upon approval of the Qualifications Review Committee.
