### A-1 38 Units and Graduation Requirements

Assistant Commissioner for Learning Services Ms. Stacy Smith said the updated form was being presented to the State Board. Ms. Smith said there were no changes to Smart Core or the 38 Units and Graduation Requirements.

Ms. Chambers moved, seconded by Ms. Newton, to approve 38 Units and Graduation Requirements. The motion carried unanimously.

A-2a District Request for Waivers Granted to Open-Enrollment Charters: Little Rock School District

Public School Program Advisor Ms. Kelly McLaughlin said Horace Mann Arts and Science Magnet Middle School Principal Dr. Keith McGee Sr. and Little Rock School District Superintendent Mr. Mike Poore were present to represent the item.

Dr. Keith McGee Sr. shared a presentation. He said the waiver would allow students access to Project Lead the Way.

Ms. Zook moved, seconded by Ms. Chambers, to approve District Request for Waivers Granted to Open-Enrollment Charters made by the Little Rock School District specific to Horace Mann Arts and Science Magnet Middle School for four (4) years. The motion carried unanimously.

# A-3 Consideration of Third Round for Arkansas Better Chance 2018-2019 Renewal Grants

Department of Human Services (DHS) Education and Instruction Manager for Arkansas Better Chance Ms. Susan Underwood said an additional 10 slots were included. She said start-up funds were typically used for instructional materials.

Ms. Zook moved, seconded by Mr. Williamson, to approve Third Round for Arkansas Better Chance 2018-2019 Renewal Grants. The motion carried unanimously.

# A-4a Consideration of DCCECE Recommendation—In His Image Youth Development Center

Attorney Supervisor Ms. Jennifer Dedman said no representative for the appeal was present. She said the State Board could choose to consider the appeal abandoned and therefore denied. She said representatives from the Department of Human Services had documentation that the program voluntarily closed their doors.

Ms. Newton moved, seconded by Mr. Williamson, to deny the appeal from In His Image Youth Development Center. The motion carried unanimously.

# B-1 Consideration of Appeal from Denial of School Choice Application—Smith Family

Attorney Supervisor Ms. Jennifer Dedman said Mr. Brad and Mrs. Amy Smith were the parents representing the appeal.

Ms. Dedman said the non-resident district was Ouachita School District and the resident school district was Malvern School District.

Ouachita School District Superintendent Mr. Larry Newsom said they would have accepted the student if Malvern School District had not reached their 3% cap for out-of-district transfers.

Malvern School District Chief of Staff Mr. Jace Roberts said they denied the application based on the 3% cap.

Ms. Newton moved, seconded by Ms. Chambers, to deny school choice appeal filed by the Smith family. Opposed by five (5). Final vote 3-5. The motion was defeated.

Ms. Zook moved, seconded by Mr. Williamson, to approve school choice appeal filed by the Smith family. Opposed by two (2). Final vote 5-2. The motion carried.

# B-2 Praxis® English to Speakers of Other Languages (5362) for English to Speakers of Other Languages Ancillary License

Public School Program Coordinator Ms. Joan Luneau said the license area was added in April 2018.

Ms. Chambers moved, seconded by Ms. McFetridge, to approve Praxis® English to Speakers of Other Languages (5362) for English to Speakers of Other Languages Ancillary License. The motion carried unanimously.

# B-3 Certified Academic Language Therapist (CALT) Certification for Dyslexia Ancillary License

Assistant Commissioner for Learning Services Ms. Stacy Smith said the program was nationally-recognized and rigorous.

Dyslexia Specialist Ms. Vicki King said multiple cooperatives in the state hosted training sessions for this ancillary license.

Ms. Newton moved, seconded by Ms. Chambers, to approve Certified Academic Language Therapist (CALT) Certification for Dyslexia Ancillary License. The motion carried unanimously.

#### B-4 2018-2019 Embedded Courses

Public School Program Manager Mr. Thomas Coy said the Department was asking for a one-year approval for personal finance embedded courses.

Ms. Chambers moved, seconded by Dr. Hill, to approve multiyear 2018-2019 Embedded Courses. The motion carried unanimously.

Mr. Williamson moved, seconded by Ms. Newton, to approve one-year personal finance 2018-2019 Embedded Courses. Opposed by one (1). Final vote 6-1. The motion carried.

Assistant Commissioner for Educator Effectiveness and Licensure Dr. Jeremy Owoh said this action would impact those currently in the program of study.

Ms. Zook moved, seconded by Ms. McFetridge, to approve Method for Demonstrating Content Knowledge for Adding Journalism to a License. The motion carried unanimously.

B-8 Consideration for Final Approval: ADE Rules Governing the Public School Rating System on Annual School Performance Reports and the School Recognition Program

Deputy General Counsel Ms. Courtney Salas-Ford said the Department requested that the State Board release these rules for public comment.

Dr. Moore moved, seconded by Mr. Williamson, to approve ADE Rules Governing the Public School Rating System on Annual School Performance Reports and the School Recognition Program for final approval. The motion carried unanimously.
