

**Minutes
State Board Meeting
July 10, 2025**

The Arkansas State Board of Education (State Board) met Thursday, July 10, 2025. Adrienne Woods called the meeting to order at 9:02 AM, followed by a moment of silence.

Recognition

111.1. Dallas Cathey, Arkansas School for the Deaf and Blind

Item 111.1. was presented by Adrienne Woods.

On May 9, 2025, Dallas Cathey, a student at the Arkansas School for the Deaf and Blind, served as a guest broadcaster for the Little Rock Trojans baseball team, taking a step toward his dream of a career in sports broadcasting. Blind since birth, Cathey experiences baseball through sound, and on May 9, he introduced Trojan batters, sharing their statistics and hometowns. UALR baseball coach Chris Curry and play-by-play announcer Max Coltrane praised Cathey's baseball knowledge and work in the broadcast booth.

Mr. Cathey, a lifelong baseball enthusiast from Warren, introduced board members and the 2025-2026 State Board of Education officers.

111.2. Director Rachel Parker, Ferncliff Nature Preschool

Item 111.2. was presented by Leigh Keener.

Rachel Parker is the director of the Ferncliff Nature Preschool, the first preschool of its kind in Arkansas. Preschoolers spend approximately 80% of their time outside at school, learning through activities that include taking nature walks, interacting with farm animals, creating natural structures, and using natural materials to create works of art.

Director Parker was named 2024 Arkansas Environmental Education Association (AEEA) Outstanding Formal Environmental Educator and was featured in AEEA news article dated December 17, 2024.

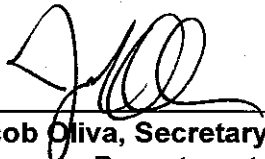

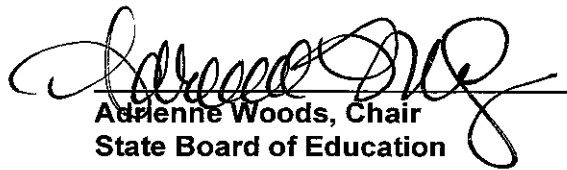
Leigh Keener requested an update on Blytheville School District; Secretary Oliva said updates would be provided in August.
