The Arkansas State Board of Education (State Board) met Thursday, October 10, 2024. Dr. Sarah Moore called the meeting to order at 9:02 AM, followed by a moment of silence.

**III.1. Carl Smith, Pine Bluff School District Bus Driver Credited with Saving Police Officer's Life**

Item III.1. was presented by Secretary Oliva. Also present from Pine Bluff School District were Mr. Carl Smith, Bus Driver; Ms. Jennifer Barbaree, Superintendent; Mr. Kalan Davis, Transportation Director.

In advance of 2024 National School Bus Safety Week, October 21-25, the State Board of Education was pleased to recognize Mr. Carl Smith, Pine Bluff School District bus driver. On August 26, 2024, Mr. Smith used his bus' fire extinguisher to save the life of Pine Bluff police officer Anthony Kirkpatrick. Mr. Smith, a retired teacher and coach, has been recognized by many, including the Pine Bluff City Council for his heroic actions.

The National Association for Pupil Transportation recognizes the third full week of October as National School Bus Safety Week.

### **V.1. Request to Approve ATLAS Cut Scores**

Item V.1. was presented by Ms. Stacy Smith, Deputy Commissioner.

The Arkansas Department of Elementary and Secondary Education requested State Board approval of the cut scores for the Arkansas Teaching, Learning & Assessment System (ATLAS). The ATLAS cut scores were requested for assessments for grades K-10 in English language arts, math and science and end-of-course exams in Algebra 1, geometry, and biology.

A motion to approve the ATLAS assessment cut scores for grades K-10 in English language arts, math, and science and end-of-course exams in Algebra 1, geometry, and biology was made by Mr. Ken Bragg and seconded by Mr. Randy Henderson. The motion unanimously passed.

### **V.2. 2025-2027 Arkansas Governor's School Site Selection Committee Recommendation**

Items V.2. was presented by Dr. Kiffany Pride, Assistant Commissioner, Learning Services. Also present via Zoom were co-chairs Summer Williams and Jill Clogston.

Presidents and Chancellors of all four-year colleges and universities were invited to submit proposals to host the 2025-2027 Arkansas Governor's School (AGS). A proposal was received from Arkansas Tech University (ATU). The site selection committee reviewed the proposal and conducted a site visit to the institution. Their recommendation for the proposed site for 2025-2027 was presented to the State Board for approval. A summary of the AGS Site Selection Procedures used to determine the site recommendation and proposal materials submitted by ATU were included in State Board materials.

A motion to approve ATU as the site to host the 2025-2027 Arkansas Governor's School was made by Ms. Kathy Rollins, seconded by Ms. Leigh Keener. The motion unanimously passed.

#### **V.4. Consideration of Request to Repeal the DESE Rule Governing Educational Freedom Account Payment Processing**

Item V.4. was presented by Ms. Stacy Smith, Deputy Commissioner.

The request to repeal the DESE Rule Governing Educational Freedom Account Payment Processing was presented to be released for public comment. The substance of this rule was incorporated into the final DESE Rule Governing the Educational Freedom Accounts Program, which became effective on August 10, 2024. This rule is now unnecessary, and the Division requested that it be repealed.

A motion to approve the repeal of DESE Rule Governing Educational Freedom Account Payment Processing was made by Ms. Kathy Rollins, seconded by Ms. Lisa Hunter. The motion unanimously passed.

#### **V.5. Request for Waiver - LA-25-002 - Sheryl Ross**

Item V.5. was presented by Ms. Karli Saracini, Assistant Commissioner, Educator Effectiveness and Licensure and Ms. Sheryl Ross, educator.

The Arkansas Department of Education received information that the educator has a conviction for a disqualifying offense. Per Ark. Code Ann. § 6-17-410, the State Board shall not issue a first-time license and shall revoke any existing license not up for renewal of any person who has a conviction for a disqualifying offense. The educator requested a waiver.

A motion to grant the waiver request of Ms. Sheryl Ross, educator, was made by Ms. Lisa Hunter, seconded by Mr. Randy Henderson. The motion unanimously passed.


