One household was determined free and should have been denied based on income, three households were free and should have been reduced based on income and one household was reduced and should have been free based on income. 2) During the review 380 source documents were reviewed. One application was missing the signature of the person completing the application. 3) During the review 380 source documents were reviewed. Of those documents 55 of them exceeded the timeline limit for approval in accordance with 7 CFR 245.6(c)(6)(i). The district must notify the household of the children's eligibility and provide free or reduced price meal benefits to eligible children within 10 operating days of receiving the application from the household. The documents were determined past the 10 operating day deadline.
