2) All foods in the Child Nutrition Program must be labeled and dated in storage (dry storage, refrigerators, and freezers) to ensure adherence to food safety standards in Arkansas Department of Health Food Code. During observation, it was seen that foods were placed in new bags or single serving plates without being labeled and dated in the refrigerator and freezer.
