Findings:				
1) There was no contract between the school district and preschool program for contract meals. Meals provided to the preschool were not being charge at the appropriate meal rate for non-program foods to cover all cost of the contract meals.				
2) While reviewing dry storage, food items were identified as not being compliant with Buy American. No Buy American justification forms were completed for the items identify but TA was provided and forms were completed onsite.
