2) During the review 590 source documents were reviewed. Of those documents one of them exceeded the timeline limit for approval in accordance with 7 CFR 245.6(c)(6)(i). The district must notify the household of the children's eligibility and provide free or reduced price meal benefits to eligible children within 10 operating days of receiving the application from the household. The document was determined past the 10 operating day deadline.				
3) A review of the 2018-2019 verification file indicated that two households chosen for verification were denied benefits for only sending in a weeks' worth of income to verify.
