PLSB CASE NO. 20-096

FINDINGS OF FACT, CONCLUSIONS OF LAW, AND ORDER

At its regular meeting on August 13, 2020, the Arkansas State Board of Education (Board) accepted the recommendation of the Professional Licensure Standards Board Ethics Subcommittee (Ethics Subcommittee) for disciplinary action against the teaching license of Blake Barrow (Educator Barrow). Based upon Educator Barrow's response to the Ethics Subcommittee's recommendation and the evidence presented, in accordance with the Administrative Procedures Act, Ark. Code Ann. 25-15-101 et seq., the Board hereby states as follows:

I. Findings of Fact

- a. The Arkansas Department of Education issued Educator Barrow a standard five year teaching license on January 1, 2017 that expires on December 31, 2021.
- b. The Ethics Subcommittee received an allegation that Educator Barrow violated the Arkansas Department of Education Rules Governing the Code of Ethics for Arkansas Educators promulgated pursuant to Ark. Code Ann. § § 6-17-422 and 6-17-428.
- c. On February 7, 2020 the Ethics Subcommittee authorized an investigation into allegations that Educator Barrow violated Standard 2: an educator maintains competence regarding his or her professional practice, inclusive of professional and ethical behavior, skills, knowledge, dispositions, and responsibilities relating to his or her organizational position.

- d. Educator Barrow was notified on February 10, of the Ethics Subcommittee's authorization to investigate this allegation.
- e. After considering the investigator's report and evidence on June 9, 2020 the Ethics Subcommittee unanimously found that a preponderance of evidence existed to substantiate violation of Standard 2 in that Educator Barrow:
 - Exhibited an inappropriate disposition inclusive of professional and ethical behavior.
 - Failed to follow students IEP
 - Failed to follow district/state policy
- f. The Ethics Subcommittee recommended that the State Board take the following actions:
 - 1. Two Year probation;
 - 2. Assess a \$200 fine (due within 90 days of State Board Order);
- g. On June 9, 2020, Educator Barrow, was notified of the Ethics Subcommittee's initial determination and recommendation by regular mail and secure server. Educator Barrow responded to the Ethics Subcommittee's recommendation as accepted on July 8, 2020.
- h. At today's meeting, the Ethics Subcommittee's recommendation and supporting documentation were presented to the Board as part of its consent agenda.

II. Conclusions of Law

a. Upon consideration of the evidence presented at the meeting, Ark. Code Ann. §§ 6-11-105, 6-17-401, 6-17-422, 6-17-428 and 25-15-201 et seq., and the Arkansas
Department of Education Rules Governing the Code of Ethics for Arkansas
Educators, the Board adopts the Ethics Subcommittee's recommendations, and enacts

the sanctions accordingly. The Board admonishes Educator Blake Barrow for his violation of the Code of Ethics.

b. This order shall remain permanently in Educator Barrow's professional licensure file and the confidential files of the Professional Licensure Standards Board.
