FINDINGS OF FACT, CONCLUSIONS OF LAW, AND ORDER

At its regular meeting on July 9, 2020, the Arkansas State Board of Education (Board) accepted the recommendation of the Professional Licensure Standards Board Ethics Subcommittee (Ethics Subcommittee) for disciplinary action against the teaching license of Damiccah Robertson (Educator Robertson). Based upon Educator Robertson's acceptance of the Ethics Subcommittee's recommendation and the evidence presented, in accordance with the Administrative Procedure Act, Ark. Code Ann. 25-15-101 et seq., the Board hereby states as follows:

I. Findings of Fact

- a. The Arkansas Department of Education issued Educator Robertson a standard teaching license on January 1, 2017, valid until December 31, 2021.
- b. The Ethics Subcommittee received an allegation that Educator Robertson violated the Arkansas Department of Education Rules Governing the Code of Ethics for Arkansas Educators promulgated pursuant to Ark. Code Ann. § § 6-17-422 and 6-17-428.
- c. On March 6, 2020, the Ethics Subcommittee authorized an investigation into allegations that Educator Robertson violated Standard 2: an educator maintains competence regarding his or her professional practice, inclusive of professional and ethical behavior, skills, knowledge, dispositions, and responsibilities relating to his or her organizational position and Standard 3: an educator honestly fulfills reporting obligations associated with professional practices.

- d. Educator Robertson was notified on February 10, 2020, of the Ethics Subcommittee's authorization to investigate this allegation.
- e. After considering the investigator's report and evidence on May 1, 2020, the Ethics Subcommittee unanimously found that a preponderance of evidence existed to substantiate violations of Standards 2 and 3 in that Educator Robertson:
 - Inappropriate disposition inclusive of professional and ethical behavior
 - Falsified and/or manipulated student records/data and/or created false documents
 - Failed to follow school district/state/federal policies

The Ethics Subcommittee recommended that the State Board take the following actions:

- a) One year Suspension of license by the State Board of Education;
- b) Fine of \$400;
- c) ERC19048: Professional Standards Licensure Board (PLSB): The Code of Ethics
 Training Video (2018) Credit Hours: 1
- d) Title QBQ! The question Behind the question: Practicing Personal Accountability at Work and in Lite (160p) Author: John G. Miller ISBN-10: 0399152334; ISBN-13: 978-0399152337
- e) Title: The 85% Solution: How Personal Accountability Guarantees Success No Nonsense, No Excuses (256p) Author: Linda Galindo ISBN-12: 9780470500163
- f) Written reflections on how each of these trainings will impact her professionalism, interactions with students, and student information in the future.
- g) To be completed by: 30 days before the end of suspension. (All costs paid by Educator).
- h) On May 1, 2020, Educator Robertson was notified of the Ethics Subcommittee's initial determination and recommendation by first class, certified mail, and secure server.

Educator Robertson did not respond to the recommendation of the Ethics Subcommittee

which due to this, is deemed as accepted.

i) At today's meeting the Ethics Subcommittee's recommendation and supporting

documentation were presented to the Board as part of its consent agenda.

II. Conclusions of Law

a. Upon consideration of the evidence presented at the meeting, Ark. Code Ann. §§ 6-

11-105, 6-17-401, 6-17-422, 6-17-428 and 25-15-201 et seq., and the Arkansas

Department of Education Rules Governing the Code of Ethics for Arkansas

Educators, the Board adopts the Ethics Subcommittee's recommendations, and enacts

the sanctions accordingly. The Board admonishes Educator Robertson for her

violation of the Code of Ethics.

b. Educator Robertson is cautioned that further violations of the Code of Ethics or

failure to pay the fine may result in more severe discipline including permanent

revocation of his license.

c. This order shall remain permanently in Educator Robertson professional licensure file

and the confidential files of the Professional Licensure Standards Board.
