FINDINGS OF FACT, CONCLUSIONS OF LAW AND ORDER

At its regular meeting on May 9, 2019, the Arkansas State Board of Education (Board) heard the request to revoke the teaching license of Charles Clay McKewen (Educator McKewen) pursuant to Ark. Code Ann. § 6-17-410(c). Based upon the evidence presented, in accordance with the Administrative Procedures Act, Ark. Code Ann. § 25-15-101 et seq., the Board hereby states as follows:

I. Findings of Fact

- a. Educator Garcia holds a teaching license that expired December 31, 2019.
- b. The Department received information on March 22, 2019, that Educator McKewen plead guilty to two counts of the disqualifying offense, Sexual Assault First Degree, Class A Felony.
- c. The Department was notified that Educator McKewen desired to surrender his teaching license.
- d. Educator McKewen was represented by Mr. Christopher Hayes and did not request a waiver hearing and signed a Voluntary Consent to Surrender his Teaching License on April 10, 2019. (Exhibit A)

- e. Educator McKewen was notified through his attorney on April 16, 2019, that the revocation of his license would be placed on the consent agenda.
- f. The Board considered:
 - i. The educator's age at the time of the offense;
 - ii. The circumstances surrounding the offense;
 - iii. The length of time since the offense;
 - iv. The educator's subsequent work history;
 - v. The educator's employment and character references;
 - vi. Other evidence demonstrating that the applicant does not pose a threat to the health or safety of school children or school personnel; and
 - vii. Other relevant evidence.
- g. A motion was made to revoke Educator McKewen's teaching license through the consent agenda. The Board's vote in favor was unanimous. The motion carried.

II. Conclusions of Law

- a. The State Board of Education may consider a true report in the Child Maltreatment Central Registry or certain enumerated offenses as a disqualification for licensing.

 See Ark. Code Ann. §§ 6-17-410(c), 6-17-410(d) (A) (5) and 6-17-411. This includes offenses which have been expunged, sealed, and pardoned by the governor.
- b. Upon consideration of the evidence presented and pursuant to Ark. Code Ann. §§ 6-11-105, 6-17-410 and 25-15-201 et seq., the Arkansas State Board of Education revokes Educator McKewen's teaching license.
- c. Educator McKewen's Arkansas teaching license is hereby permanently revoked.

- 7. I acknowledge and understand that the Department of Education reports revocation of an educator's license to the NASDTEC Clearinghouse, which is a national database consulted by other states' licensure units.
- 8. I waive all rights I may have to any further notice, hearing, or appeal under the Arkansas Administrative Procedures Act, Ark. Code Ann. § 25-15-101 et seq.
