FINDINGS OF FACT, CONCLUSIONS OF LAW AND ORDER

At its regular meeting on April 11, 2019, the Arkansas State Board of Education (Board) heard the request to revoke the teaching license of Kevin Wayne Kyzer (Educator Kyzer) pursuant to Ark. Code Ann. § 6-17-410(c). Based upon the evidence presented, in accordance with the Administrative Procedures Act, Ark. Code Ann. § 25-15-101 et seq., the Board hereby states as follows:

I. Findings of Fact

- a. Educator Kyzer holds a teaching license that expired December 31, 2018.
- b. The Department received information on August 24, 2018, that Educator Kyzer plead guilty to the disqualifying offense, Endangering the Welfare of a Minor in the First Degree, Class D Felony.
- c. On December 3, 2018, the Department notified Educator Kyzer that he was ineligible for licensure and employment in an Arkansas public school pursuant to Ark. Code Annotated § 6-17-410 et seq.
- d. Educator Kyzer did not request a waiver hearing.
- e. Educator Kyzer consented to the permanent revocation of his Arkansas educator's license on December 27, 2018. (Exhibit A)

- f. Educator Kyzer was notified on March 5, 2019, that the revocation of his license would be placed on the consent agenda.
- g. The Board considered:
 - i. The educator's age at the time of the offense;
 - ii. The circumstances surrounding the offense;
 - iii. The length of time since the offense;
 - iv. The educator's subsequent work history;
 - v. The educator's employment and character references;
 - vi. Other evidence demonstrating that the applicant does not pose a threat to the health or safety of school children or school personnel; and
 - vii. Other relevant evidence.
- h. A motion was made to revoke Educator Kyzer's s teaching license through the consent agenda. The Board's vote in favor was unanimous. The motion carried.

II. Conclusions of Law

- a. The State Board of Education may consider a true report in the Child Maltreatment Central Registry or certain enumerated offenses as a disqualification for licensing.

 See Ark. Code Ann. §§ 6-17-410(c), 6-17-410(d) (A) (5) and 6-17-411. This includes offenses which have been expunged, sealed, and pardoned by the governor.
- b. Upon consideration of the evidence presented and pursuant to Ark. Code Ann. §§ 6-11-105, 6-17-410 and 25-15-201 et seq., the Arkansas State Board of Education revokes Educator Kyzer's teaching license.
- c. Educator Kyzer's Arkansas teaching license is hereby permanently revoked.

d. This Order shall become a permanent entry in the licensure file of the educator.

- 1. I, KEVIN KYZER, voluntarily surrender my Arkansas educator's license and any right to apply for renewal.
- 2. I understand that an educator's license means a teaching license and/or administrator's license.
- 3. I acknowledge and understand that I <u>cannot</u> apply for an educator's license in Arkansas <u>at any time</u> in the future.
- 4. I shall not apply for an educator's license at any time in the future.
- 5. I acknowledge and understand that an educator's license **shall not** be issued to me **at any time** in the future.
- I acknowledge and understand that the State Board of Education's acceptance of the surrender of my educator's license will result in its <u>PERMANENT</u> <u>REVOCATION</u> because Arkansas law has no provision for the mere surrender of an educator's license.
- 7. I acknowledge and understand that the Department of Education reports revocation of an educator's license to the NASDTEC Clearinghouse, which is a national database consulted by other states' licensure units.
- 8. I waive all rights I may have to any further notice, hearing, or appeal under the Arkansas Administrative Procedures Act, Ark. Code Ann. § 25-15-101 et seq.
