Notes:

- * The assessment data is submitted by each county official on or before March 15 each year in compliance with A.C.A. §6-20-2202(g)(1).
- * This data will be used in the state funding calculations for 2012-2013.
- * The millage data is from the annual millage election held during calendar year 2011, for taxes payable in calendar year 2012.
- * The millage rates have been adjusted for rollback provisions. Rollback data is provided by the Assessment Coordination Department.
- * The 36% Pullback is calculated in compliance with A.C.A. §6-20-401(4)(C)(i).
- * If amount collected is less than 36% of the proceeds of the local taxes that are not pledged to secure bonded indebtedness, the amount necessary to equal 36% may be accrued.
- * Districts that were consolidated or annexed and have not voted a unified millage rate are indicated with a "+" (plus sign).
For the 36% Pullback of these districts, the two calculations are added together.
- * M&O is an acronym for maintenance and operations. LEA is an acronym for local education agency.
