About the report:

As of June 30, 2019, Arkansas public school districts and education service cooperatives had registered outstanding loans and bonded indebtedness totaling \$4,993,393,603 -- an increase of \$165,296,182 over the previous year. Non-bonded debt with an energy savings contract is excluded from total indebtedness in calculating the debt ratio of school districts (Ark. Code Ann. § 6-20-405 (a)(1)(D)). Of the 235 Arkansas school districts in fiscal year 2018-2019, 2 districts had no debt; 38 districts had a debt ratio over 0% up to 5%; 86 districts had a debt ratio over 5% up to 10%; 72 districts had a debt ratio over 10% up to 15%; 25 districts had a debt ratio over 15% up to 20%; 7 school districts had a debt ratio over 20% up to 25%; 5 school districts had a debt ratio over 25%.

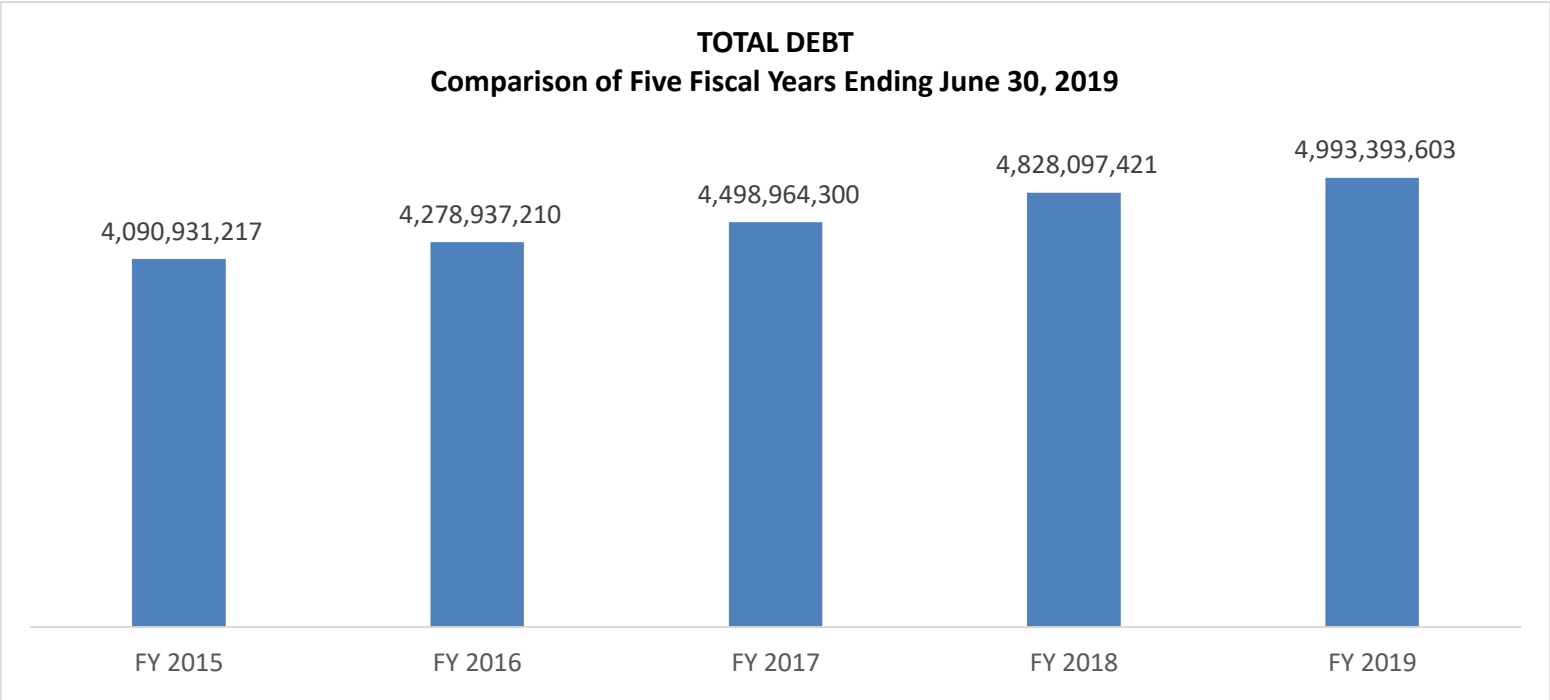
Postdated warrants, lease purchase agreements, and installment contracts must be registered with the Department of Education and "shall be a part of the total debt of the district" (Ark. Code Ann. § 6-20-402 (b)(3)(A)).

The calendar year 2018 statewide average millage rate for school districts in Arkansas was 38.53 mills.

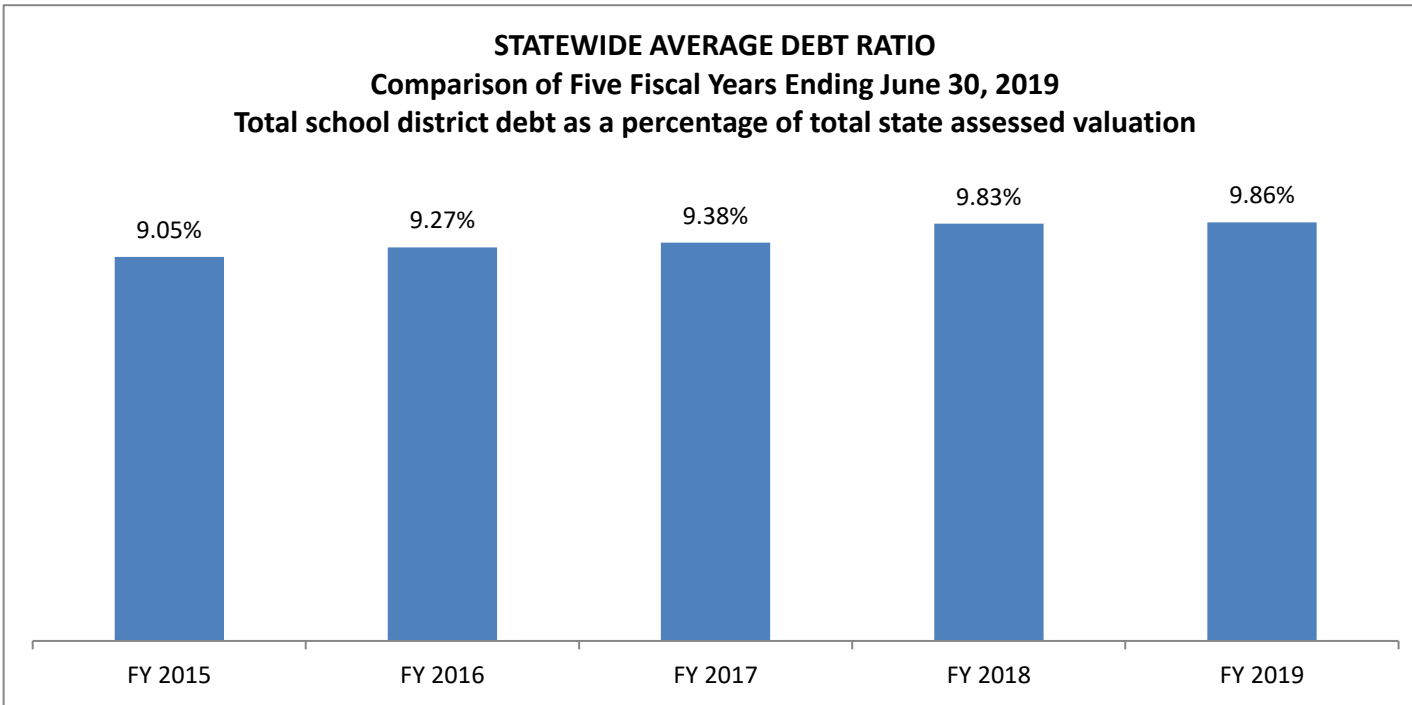

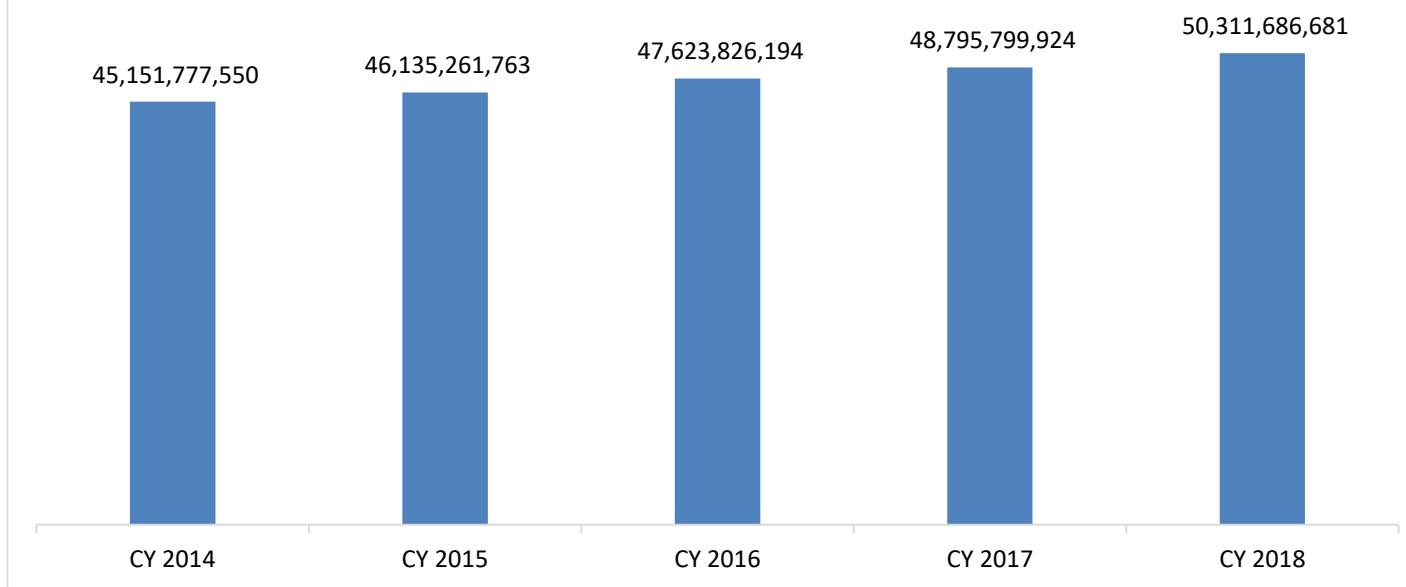


Total debt for Arkansas public school districts and education service cooperatives increased by \$165,296,182 (3.42%) from fiscal year 2018 to fiscal year 2019.

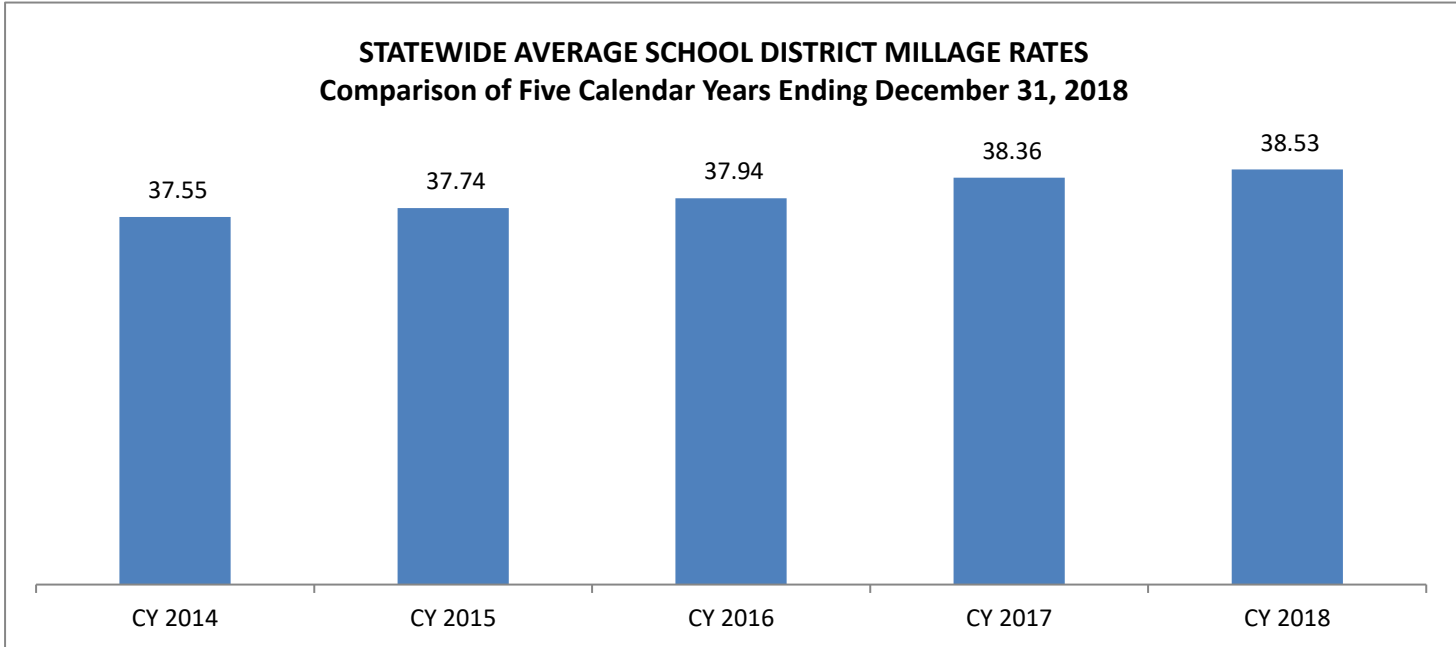

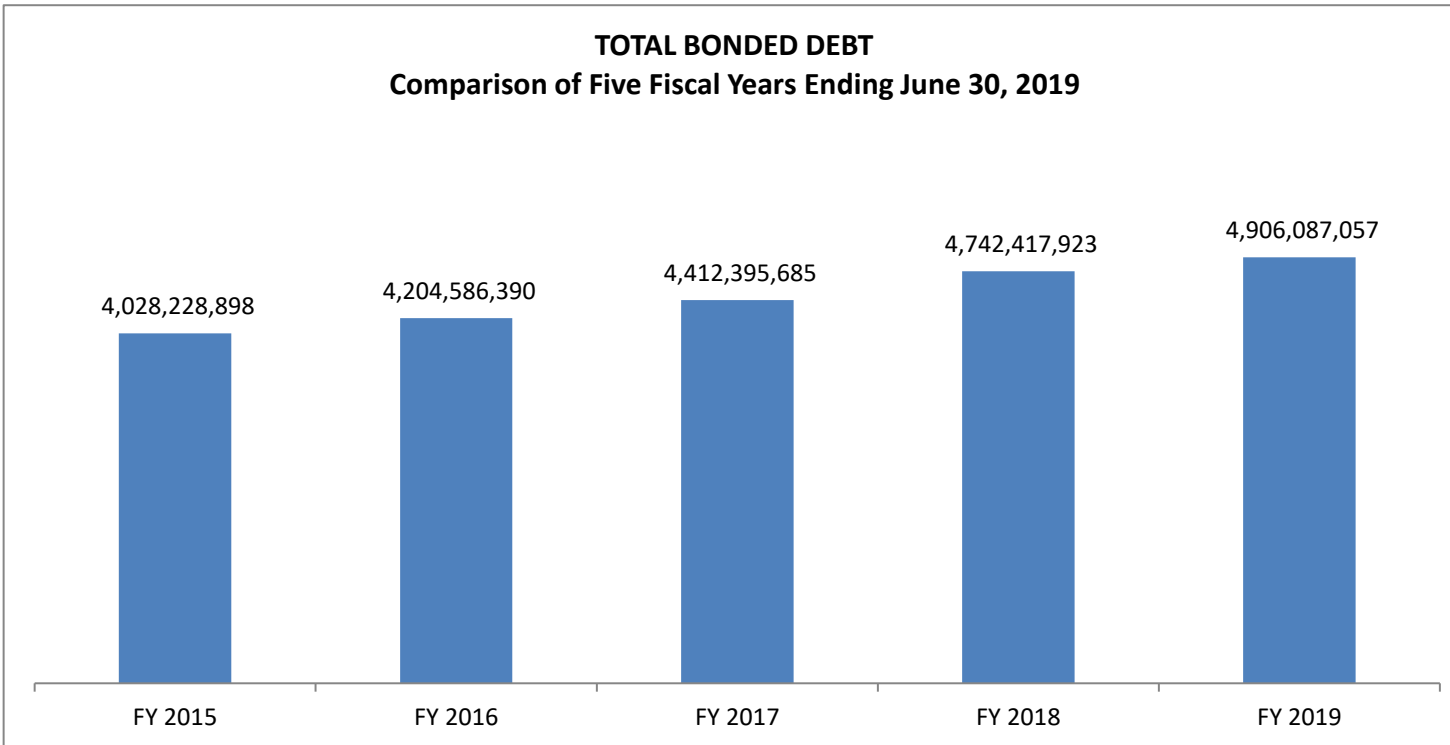

Comparison of Five Calendar Years Ending December 31, 2018



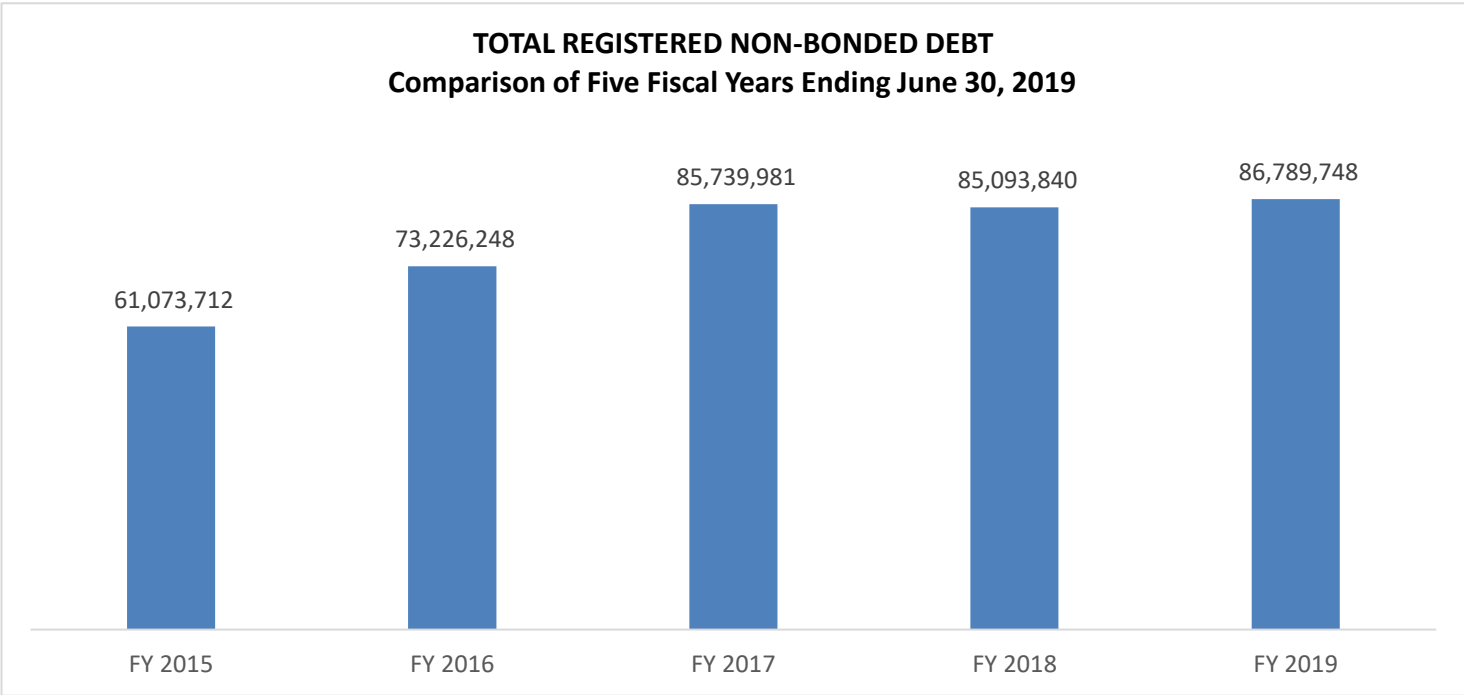

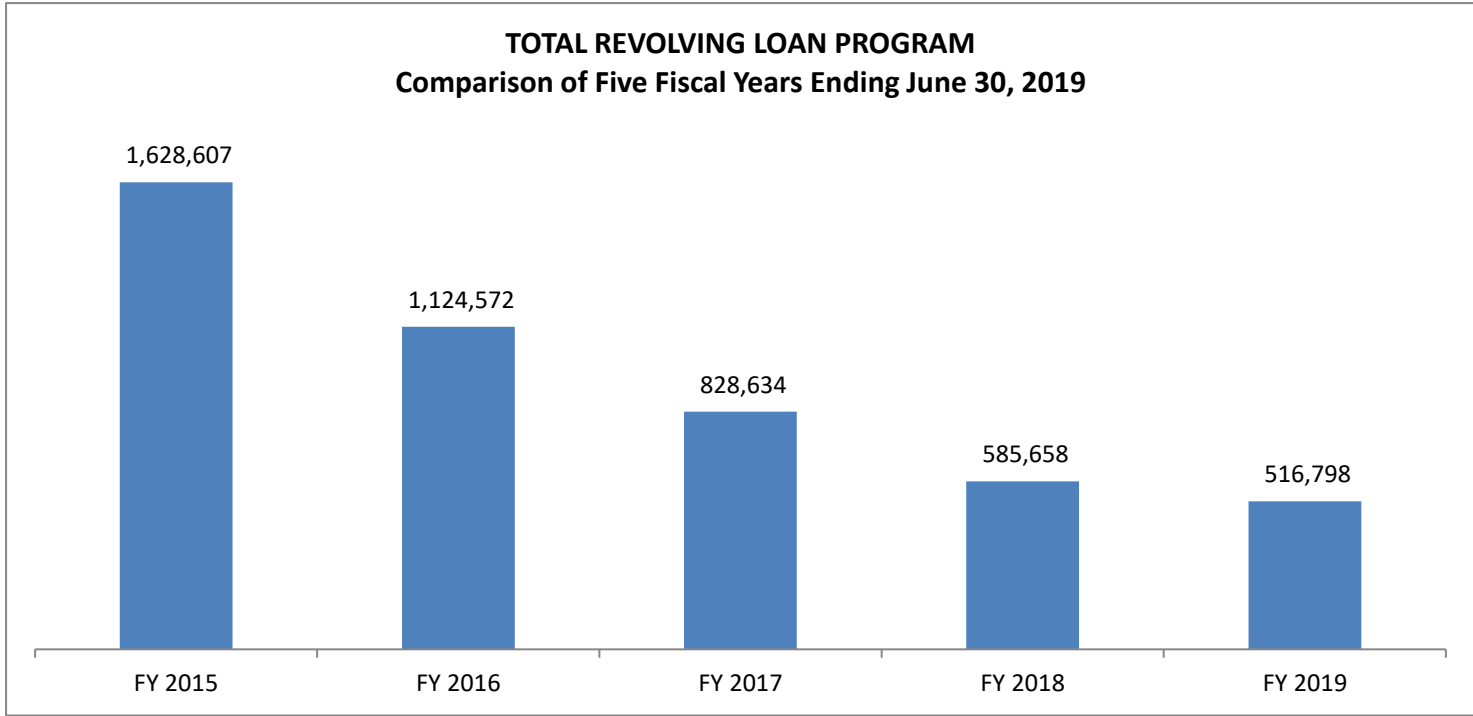
The statewide average millage rate for school districts increased 0.17 mills (0.43%) from 2017 to 2018



Total bonded debt for Arkansas public school districts increased by \$163,669,134 (3.45%) from fiscal year 2018 to fiscal year 2019.



Total registered non-bonded debt (installment contracts, lease purchases, postdated warrants) for Arkansas public school districts and education service cooperatives increased by \$1,695,908 (1.99%) from fiscal year 2018 to fiscal year 2019. This includes debt with an energy savings contract.



Total revolving loan debt for Arkansas public school districts and education service cooperatives decreased by \$68,860 (-11.76%) from fiscal year 2018 to fiscal year 2019.
