Testing Guidance

2020-2021

The Arkansas Division of Elementary and Secondary Education Office of Student Assessment is providing guidance to districts on recommended best practices for testing in the 2020-2021 school year. The Student Assessment team is implementing flexibilities to support districts and schools as they plan to meet the needs of all students, including being ready to pivot as needed. This document is intended to provide important considerations for the flexibilities available to districts and schools for 2020-2021 testing. One flexibility that is available for 2020-2021 is the option to test at home for some assessments. It is important to note that remote testing is not available for all assessments. Remote testing is available for the **K-2 assessments** (fall and winter windows only), **3-8 Ready for Learning assessments**, **ACT Aspire Periodic assessments (Interim and Classroom)**, and the **Civics Exam**. Remote testing is not currently available for K-2 (spring window), ACT Aspire Summative assessments, DLM, ELPA21, ACT, or PSAT.

When utilizing the available option for remote testing, districts should be mindful to balance the flexibilities provided by remote testing with the potential loss of test security and the validity and reliability of results. The most ideal scenario is one in which students adhere to the Arkansas Department of Health and Division of Elementary and Secondary Education guidelines, test at school with a test administrator who is an employee of the district, who has been trained in test administration and test security, and who has signed the appropriate test security agreement. To this end, the Office of Student assessment has provided flexibilities to allow on-site testing outside of a traditional school schedule. When testing at school is not an option (e.g., when students are receiving instruction in a 100% virtual setting), precautions must be taken to mitigate the risk of remote testing on test security and the validity and reliability of results.

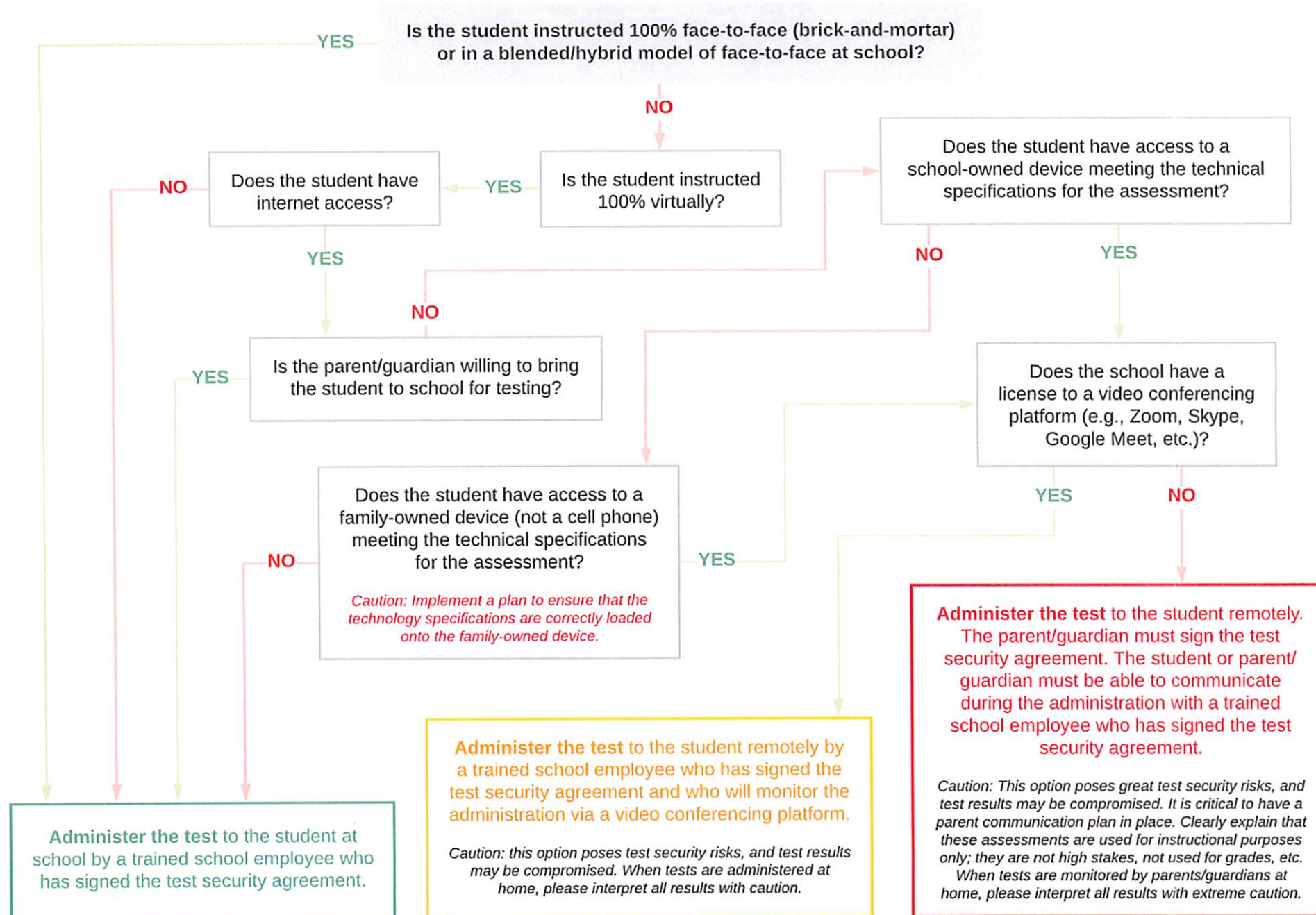
The following decision tree diagrams are intended to support schools in selecting the testing option that will provide the greatest amount of test security and the most valid and reliable results.

Remote testing

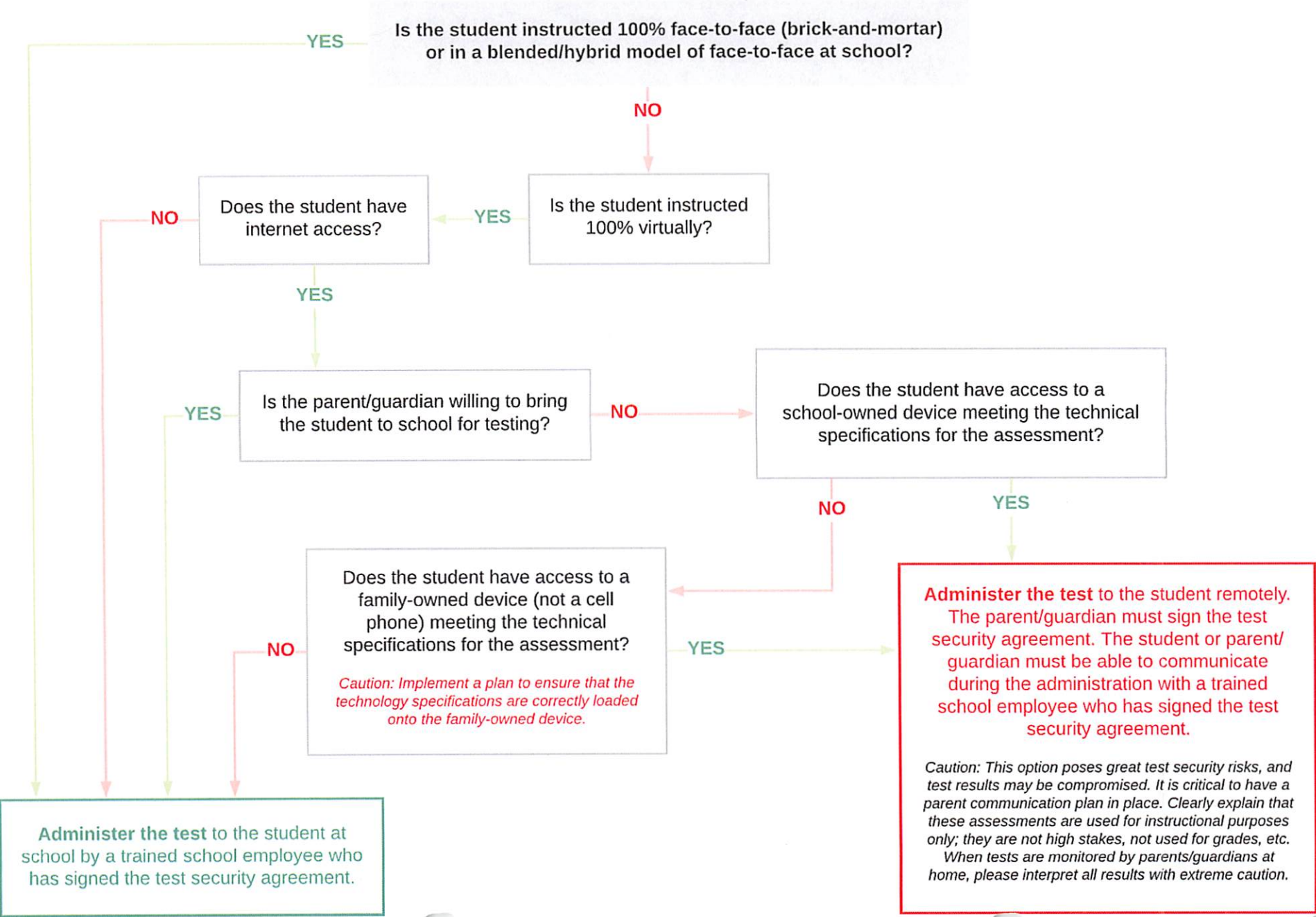
Note: Remote testing is not currently available for K-2 (spring window), ELPA21, DLM, the ACT, PSAT, or any summative assessments.

1. ELPA21 - There are only three (3) ways to screen:

- a. Student comes in to district building or other agreed upon location to be screened (following all Arkansas Department of Health guidelines and [DESE's Re-Entry to Onsite Activities](#)),
- b. District personnel goes to student's home with district device, headset(s), mouse, and hotspot to screen (following all Arkansas Department of Health guidelines and [DESE's Re-Entry to Onsite Activities](#)), or
- c. District sets up remote testing site (e.g. library, church, community center, apartment lobby, mobile bus testing station, meal delivery sites) utilizing district device, headset(s), mouse, and hotspot (following all Arkansas Department of Health guidelines and [DESE's Re-Entry to Onsite Activities](#)).

Device prep: Sanitize device, headset(s), and mice between users (TA/Student and Student/student); consider using a splitter for the TA to hear the audio via their own designated headset; if no one else is in the room, speakers may be used.

Things to think through: Waiting process for parents; timeline communication with parents

2. DLM - There are two (2) ways to test:

- a. Students who receive Homebound services according to Homebound placement in IEP may test at home.
 - i. See [Guidelines for Test Security for Homebound Test Administration](#).
 - ii. Changing a student's placement to homebound simply for the sake of testing at home is not appropriate.
- b. Students come to a district building to test.
 - i. Assessing students with the most significant cognitive disabilities is to be individualized and not be conducted in a group setting. Educators may give more than one testlet at a time, depending on the student's needs - be mindful of student testing fatigue and opportunity for best performance. Teachers should not give all testlets in one day.
 - ii. Students must be rostered to the test administrator
 - iii. TA must have student login information
 - iv. Device must have Kite student portal app

- c. Things to consider:
 - i. To avoid placing undue stress upon this student population, it is recommended that testing be scheduled over a period of several weeks and not bunched at the end of the window.
 - ii. The average duration of the assessment is 5-15 minutes per testlet. The total testing time varies, depending on the number of testlets necessary to meet the blueprint coverage for the grade and content.
 - iii. Not every day is a good day to assess; additional make-up sessions may be required.
 - iv. Testlets may be administered in a classroom, computer lab, multipurpose room, or other school setting. The space must be quiet, free from distractions, and located where the testlets/screen can not be seen by others.

- Pre-administration training for parent(s)/guardian(s) for remote testing
 - Test Security Agreement Non-summative: Parents
 - Procedures for testing
 - Testing schedule
 - Content/test
 - Building/grade
 - Date/time
 - Plan for disseminating passwords to individual students (not via email)
 - Test session monitoring during administration
 - Quiet environment, free from distraction (preferably a room with a closing door)
 - A responsible person may assist the student in logging into the assessment. After the login process, it is best practice for anyone who is not monitoring the test to be away from the testing area.
 - Technology troubleshooting plan - vendors provide support to districts; districts provide support to parent(s)/guardian(s)
 - Communication plan
 - Who will be the point of contact between the parent and school?

- How will information be communicated?

- Ensure that students are familiar with the testing platform prior to test day.
