

ADE is, therefore, required to secure and arrange for recovery of all personal property, equipment, and fixtures purchased or financed in whole or in part with any state or federal funds, and any personal property or equipment contained within the charter school facility are presumed to have been purchased or financed in whole or in part with state or federal funds until such time as the sponsoring entity furnishes documentation showing otherwise. Lastly, at all times the charter school, the sponsoring entity, and their officers, agents, and employees must protect the school's assets against theft and misappropriation.


Beginning January 29, 2019, you were instructed to obtain ADE approval to pay any outstanding debt or incur new debt and to buy additional supplies or resources. As stated in the January 29, 2019, letter you do not need approval to pay operating costs such as rent, food, insurance, salaries, etc. Beginning **immediately**, no person from City of Fire or Covenant Keepers Board, or their agents, may enter and remove any item or document from Covenant Keepers without approval from Superintendent Tran and proper documentation, including the serial number, description, person removing the item, and verification that the item is not State property. Every item or document removed from Covenant Keepers must be logged and the person removing the item must sign for it. Further, no member of the public may enter and remove items or documents from the school, even if at the direction of the Board.

All items that have been removed from Covenant Keepers since January 15, 2019, must be returned immediately. You are further instructed to provide a detailed accounting of all items removed, including documentation evidencing that those items were not purchased or financed, in whole or in part, by state or federal funds.

Failure to comply with this letter will lead to immediate action including, but not limited to, withholding all state and federal funds and notifying your financial institutions that the accounts hold state and federal funds and directing that the accounts be immediately frozen.

To Mr. Tatum,

As per my email on January 14<sup>th</sup> to you and Dr. Tatum (your wife), no equipment, furniture or any other items at the school may be removed without going through the proper protocol. You had emailed back stating that you gave her permission to do so. That being said, my directives were ignored as Dr. Tatum came back on Saturday, February 2<sup>nd</sup> to remove more furniture and equipment from the school.

As per the letter sent to you and the Board of Directors on February 7<sup>th</sup>, from the Arkansas Department of Education, "no person from City of Fire or Covenant Keepers Board, or their agents, may enter and remove any item or document from Covenant Keepers without approval from Superintendent Tran and proper documentation, including the serial number, description, person removing the item, and verification that the item is not State property." Also stated, "no member of the public may enter and remove items or documents from the school, even if at the direction of the Board."

Per the directives from the Arkansas Department of Education, all items that Dr. Tatum have removed from the building must be returned to the school. We will then follow the proper protocol to return those properties to Dr. Tatum as long as she could provide proper documentation per the letter.

Moving forward, Dr. Tatum may no longer step foot on Covenant Keeper's ground without making an appointment with Principal Chapman or myself. The police will be called if this directive is not adhered to. This is a non-negotiable. Furthermore, no furniture, equipment, items or documentation may be removed from Covenant Keepers without my approval.

## FRIENDSHIP ASPIRE ACADEMY-MIDDLE SCHOOL SCHOOL TRANSITION PLAN

### Goal

The Friendship Aspire Academy is prepared to immediately assume the operations of the former Covenant Keepers College Preparatory PCS should the State decide to revoke the charter of the school and amend our charter. Friendship is prepared within the next 7 days to relocate the students, staff, instructional and administrative operations of the school through the end of the SY2018-2019. Our goal is to ensure the least disruption to the instruction and education of the 105 students, (6<sup>th</sup> through 8<sup>th</sup> grade) current enrolled at the school. We will also ensure improved academic results, tighter financial control, stronger management and a new governance body. Our plan for doing so is as follows:

### Current Student Enrollment

105 students. Friendship intends to accept all 105 current students. We will also have the capacity to accept an additional 100 new students should lottery be required.

### New School Location


Friendship Aspire Academy Garland Campus located at 3615 W 25<sup>th</sup> St in Central/SW Little Rock. The new location is less than 1.8 miles (7 minutes) from the former CK school at 5615 Geyer Spring Rd. The school has 10 classrooms, science lab, computer lab, SPED room, playground, cafeteria, and administrative offices. (See attached pictures of Garland school)

### Instruction

Instruction will continue. We are committed to ensuring instruction without disruption and students will benefit from having the same teachers, support staff and leadership in a significantly, improved environment. Students and families will have the teachers they know in a brand new, state of the art, facility.

### Transportation

Friendship is prepared to offer transportation to students on the 1st day of school at the new location. We have two full-size (50 passenger) school bus ready to pick up and drop off students based on the current bus route.



## **Food Service and Vendor Services**

Current school food service provider will provide prepared meals to our students at the new location at the same rate.

## **Furniture, Equipment, Supplies**

Friendship intends to transfer student records, 25 student desktops computers, 80 Chromebooks, 2 office copiers, curriculum and lesson materials. Any equipment and furniture moved will be approved by ADE.

## **Testing**

Friendship intends to continue and finish ELPA 21 testing by the 22<sup>nd</sup> of February.



## ACT Aspire Proficiency Growth





I am writing to support the expansion application of Friendship Public Charter Schools to the Covenant Keepers Charter Middle School in Little Rock, currently serving grades 6-8.
