Two students were incorrectly given categorically free status because they shared a household with another categorical student. b. One applications was incorrectly calculated to be eligible for reduced priced meals when it should have been denied. c. One application had been incorrectly calculated to be eligible for reduced priced meals when it should have been free. d. One application had been incorrectly calculated to be eligible for free priced meals when it should have been reduced.
