# C-2 Commitment to Principles of Desegregation Settlement Agreement: Report on the Execution of the Implementation Plan

# C-4 Report on Waivers to School Districts for Teachers Teaching Out of Area for Longer than Thirty (30) Days, Ark. Code Ann. § 6-17-309

Act 1623 of 2001 requires local school districts to secure a waiver when classrooms are staffed with unlicensed teachers for longer than 30 days. Waiver requests were received from 16 school districts covering a total of 23 teaching positions. Long term substitute waivers were requested from 20 school districts for a total of 24 waivers. None of these requests were from a district in academic distress. These requests have been reviewed, either approved or denied by Department staff and are consistent with program guidelines.

#### C-5 Review of Loan and Bond Applications

Pursuant to Arkansas Code Annotated § 6-20-805 and § 6-20-1205, the State Board of Education must approve all Revolving Loan Fund and Commercial Bond applications, with the exception of non-voted refundings of commercial bond issues that meet the minimum savings as required by the Rules and Regulations Governing Loan and Bond Applications, Section 9.02. It is recommended that the State Board of Education review the following: Revolving Loans – 1 School Bus – Recommend Approval - Commercial Bonds –10 2nd Lien Bond Applications – Recommend Approval; 7 Voted Bond Applications – Recommend Approval.

#### C-6 Progress Report on the Status of Districts Classified in Fiscal Distress

Currently five districts are classified by the State Board as being in Fiscal Distress. Department staff conducts on-site visits; reviews district financial improvement plans and financial reports, and works with Fiscal Distress districts on issues specific to the individual districts. The five districts in Fiscal Distress are: Armorel, Forrest City, Helena-West Helena, Strong-Huttig, and Yellville-Summit. The Department is requesting the State Board to accept this report in compliance with A.C.A. § 6-20-1908(g), which requires the Department to submit an evaluation on the status of each district in Fiscal Distress every six months.

#### C-7 Consideration of Recommendation of the Professional Licensure Standards Board for Probation of License for Two (2) Years with Quarterly Reports and a Fine of \$75 for Case #09-042 – Ronald Hart

Per his request, Mr. Hart was granted an evidentiary hearing on November 12, 2010, at which time the recommendation that his license be suspended for one (1) year with a fine of \$100 was modified to the following: The Professional Licensure Standards Board's Subcommittee on Ethics is recommending probation of the teaching license of Ronald Hart for two (2) years, quarterly reports and a fine of \$75 for violation of Standard 1: An educator maintains a professional relationship with each student, both in and outside the classroom and Standard 3: An educator honestly fulfills reporting obligations associated with professional practices.

On December 2, 2010, Mr. Hart and his attorney were notified of the new recommendation. After numerous attempts to contact him by PLSB and his attorney, Mr. Hart has failed to accept this recommendation in the allotted timeline.

The PLSB sub-committee requests the State Board's approval of the two-year probation and a fine of \$75.

#### A-2 Consideration for Awarding Waiver Day - Jasper School District

The deadline for appeal is March 24, 2011, and no appeal was filed.

# A-8 Consideration of Acceptance of Surrender of Teaching License by Ginger Robbin Garcia

Ginger Robbin Garcia surrendered her teaching license as a part of a plea agreement in Crawford County for theft by deception from the school/district. Her attorney, Greg Alagood, submitted a confirmatory letter from Ms. Garcia surrendering her license. A copy of the criminal judgment is on file in the Professional Licensure Standards Board office.

#### A-9 Hearing on PLSB Case #09-084 Steven Lynch

#### A-11 Consideration of Request to Suspend the Teaching License of Five (5) National Board of Professional Teaching Standards (NBPTS) Candidates Who Owe Money to ADE

As ADE continues to close outstanding NBPTS accounts, several unresolved balances have been discovered. These cannot be waived or closed without the approval of the State Board. All of these are several years old and need to be resolved. The teaching license status of one (1) of these individuals is listed as current (teaching out of state), while the other four (4) educators have recently expired licenses--Sam Davis, \$2,450 from 2005;

*Glenda Formby,* \$2,300 from 2004; Teresa Garrett, \$2,668 from 2007; Michael Holcomb, \$2,444 from 2001; Lamarcia Miller, \$2,435 from 2003.

As provided in Ark. Code Ann. § 6-17-413 (b) (3), the State Board of Education may suspend the Arkansas teacher's license of any person that fails, when required to do so, to repay moneys contributed by the Department for the certification program of the national board. All of these candidates were unsuccessful in completing the program and according to A.C.A. § 6-17-413 (b)(3) are required to repay the Department.

All efforts to contact these people and secure repayment have been unsuccessful. Therefore, the Office of Teacher Quality requests suspension of the above referenced teachers' licenses until such time as the fees owed have been repaid. An APSCN search indicated that three educators are presently employed in an Arkansas public school; therefore, the request is that June 1, 2011, be the effective date for the suspensions.

# A-12 Consideration of New Praxis II Cut Scores in Art and Principles of Learning and Teaching (PLT) to be Effective September 1, 2011

Recommendation of new Praxis II Assessments and appropriate cut scores are as follows:

- 1) Art Content Knowledge exam (#0134) with a recommended cut score of 158. This exam replaces exam #0133.
- 2) Art Content and Analysis exam (#0135) with a recommended cut score of 161. This exam replaces exams #0131 and #0132.
- 3) PLT: Early Childhood exam (#0621) with a recommended cut score of 157. This exam replaces exam #0521.
- 4) PLT: Grades 5-9 exam (#0623) with a recommended cut score of 160. This exam replaces exam #0523.
- 5) PLT Grades 7-12 exam (#0624) with a recommended cut score of 157. This exam replaces exam #0524.

Educational Testing Service will begin the administration of these new Praxis II exams fall of 2011. Therefore, the recommended effective date for all five exams is September 1, 2011.

# A-13 Consideration of Waiver Requests for Licensure Purposes of Teachers Assisting in the Development of the Praxis II Examination for Instructional Facilitators

ADE Professional Licensure Office is requesting a waiver from testing for the eleven (11) Arkansas teachers who helped in the development of the Praxis II examination for instructional facilitators.

Per Rick Tannenbaum, Research Director at Educational Testing Service (ETS), the following rationale was provided: There were no other "already licensed" individuals to participate in the development of this test because it is a new licensure area which meant individuals had to be identified who had completed all the other requirements to assist in test development.

- A) Therefore, if these teachers took the exam the decision applied to a person's test score would be invalid.
- B) If a test taker has prior exposure, through writing or reviewing items, the strength of that exam is weakened. There is also a question of fairness since test takers who have had previous exposure to the items are advantaged over those test takers who have never seen the items on the form.

ETS has determined that both these issues weaken the defensibility of the licensure decision and that the teachers who assisted in the writing of this exam should be exempt from taking the exam for licensure purposes.

This information was shared with the Professional Licensure Standards Board at its regular monthly meeting on March 11, 2011. The Board, by unanimous vote, supported the waiver of testing for those individuals involved in the test development.

Jeremy Lasiter, General Counsel, provided conditions under which school districts could be granted waivers of the 178-day requirement.

# Consideration for Awarding Waiver Days – Cedar Ridge School District

Superintendent Ann Webb presented a proposal that included extending the school day to make up days missed due to inclement weather.

Board members were hesitant to set a precedent for using extended hours to make up missed days.

Commissioner Kimbrell said permitting longer school hours to compensate for missed days could allow school districts that normally operate an instructional day of more than the required six hours argue that they shouldn't have to make up missed days. He suggested a review of all standards could help with better school operations.

Ms. Newton moved, seconded by Ms. Saviers, to deny the request. The motion carried. Ms. Mahony voted no.

# Consideration for Awarding Waiver Days – Deer/Mt. Judea School District

Richard Denniston, Superintendent at Deer/Mt. Judea, reported the Deer campus in his district missed 12 days due to inclement weather while the campus at Mt. Judea missed a total of 13 days. He said the district would make up 10 days by using spring break and the five days built into the calendar. Mr. Denniston requested a two-day waiver for Deer and a three-day waiver for Mt. Judea. Ms. Mahony moved, seconded by Ms. Gullett, to grant the two-day waiver at Deer and the three-day waiver at Mt. Judea. The motion carried unanimously.

# Consideration for Awarding Waiver Days – Elkins School District

Superintendent Megan Witonski asked the Board to allow the Elkins School District to add 45 minutes to the school day for a period of time to make up two of the twelve days missed due to inclement weather.

Ms. Mahony moved, seconded by Ms. Burrow, to deny the waiver. The motion carried unanimously.

Mr. Ledbetter moved, seconded by Ms. Newton, to expunge the vote. The motion carried unanimously.

Mr. Ledbetter moved, seconded by Ms. Mahony, to deny the request to extend the school day, but granted the district a two-day waiver. The motion carried unanimously.

# **Consideration for Awarding Waiver Days – Fayetteville School District**

The Fayetteville School District requested a waiver to extend the school day one hour for 18 days to make up a portion of the 10 days missed due to inclement weather.

Ms. Burrow moved, seconded by Mr. Ledbetter, to deny the waiver. The motion carried unanimously.

# Consideration for Awarding Waiver Days – Ozark Mountain School District

Joe Hulsey, Superintendent at Ozark Mountain School District, requested a waiver to extend the school day 45 minutes for 16 days to make up two of the 12 days missed due to inclement weather.

Ms. Mahony moved, seconded by Ms. Newton, to deny the request to extend the school day, but granted the district a two-day waiver. The motion carried unanimously.

# **Consideration of the Removal of Mansfield School District from Fiscal Distress Classification Effective March 14, 2011**

Bill Goff, Assistant Commissioner for Fiscal Services, reported the Mansfield School District had met all criteria for being removed from fiscal distress. Ms. Gullett moved, seconded by Ms. Saviers, to approve the removal of Mansfield School District from fiscal distress classification. The motion carried unanimously.

# **Consideration of the Removal of McGehee School District from Fiscal Distress Classification Effective March 14, 2011**

Bill Goff, Assistant Commissioner for Fiscal Services, reported the McGehee School District had met all criteria for being removed from fiscal distress.

Ms. Newton moved, seconded by Ms. Mahony, to approve the removal of McGehee School District from fiscal distress classification. The motion carried unanimously.

# **Consideration of the Removal of Osceola School District from Fiscal Distress Classification Effective March 14, 2011**

Bill Goff, Assistant Commissioner for Fiscal Services, reported the Osceola School District had met all criteria for being removed from fiscal distress.

Mr. Cooper moved, seconded by Ms. Burrow, to approve the removal of Osceola School District from fiscal distress classification. The motion carried unanimously.

# Request for Open Enrollment Public Charter School Charter Amendment: eStem Elementary Public Charter School

John Bacon, e-Stem Executive Director, presented a proposal to amend the charter of the eStem Elementary to increase the maximum enrollment from 360 to 462 students.

Chris Heller, an attorney for the Little Rock School District, argued against the increase. Mr. Heller said, as part of Little Rock's case against the state, he had requested information showing whether the students who attend charter schools in Pulaski County previously attended magnet schools or participated in majority-to-minority programs in the traditional public schools in Pulaski County. He said the information had not been provided.

Board members indicated an interest is seeing the information and requested Department employees to provide the report.

Ms. Saviers moved, seconded by Ms. Burrow, to approve the request to expand the enrollment cap. The motion carried six to one in a roll call vote.

## Review of Open Enrollment Public Charter School: Osceola Communication, Arts and Business School, Osceola, AR

Ray Cooper, Director of the Osceola Communications, Arts and Business School, asked the Board for a year to refocus the school on helping former dropouts up to age 22 obtain diplomas. Mr. Cooper said the school was partnering with SIA-Tech, a national organization that provides education programs at federally funded centers, to refine its program.

Board members acknowledged the community should be afforded options. They suggested the school needed a restart.

Mr. Ledbetter moved, seconded by Ms. Gullett, to revoke the charter effective at the end of the school year. The motion carried unanimously.

# Review of Open Enrollment Public Charter School: Little Rock Urban Collegiate Public Charter School for Young Men

Bill Goff reported that UCPC was projected to end the school year with an illegal budget deficit of \$253,647. He said the school had approximately \$5,000 in the bank and a payroll of more than \$70,000 to make.

In July, the school reported an enrollment of 596 students when the actual enrollment on that date was 297 students. The inflated enrollment numbers allowed the school to receive more funds than it was due.

Jackie Jackson, Founder and Executive Director of UCPC, said the school could make the payroll by drawing on a line of credit. She also said the school could erase part of the projected deficit with federal funds due the school. Ms. Jackson said school leaders planned to seek grants and conduct fundraisers.

Several parents spoke in support of the school. They said their children were having positive learning experiences and asked that the school be allowed to remain open.

Dr. Kimbrell expressed grave concern with the debt for the current year and the improbable financial stability in 2011-2012.

Ms. Gullett moved, seconded by Ms. Mahony, to revoke the charter of UCPC immediately. The motion carried unanimously.

# **Consideration of Request to U.S. Department of Education for Waiver of Adequate Yearly Progress**

Commissioner Kimbrell explained the challenge the state's schools would have transitioning to the Common Core State Standards and a new assessment system while maintaining the current content standards and assessments. He asked the Board to approve a request to the U.S. Department of Education for a waiver of Adequate Yearly Progress. Specifically, the state requested that AYP targets be held at the 2011-2012 levels until the complete transition to the new standards and implementation of the new assessments.

Mr. Cooper moved, seconded by Ms. Saviers, to request the waiver. The motion carried unanimously.

# Hearing on Waiver Request for Certified Teacher's License-Lucille Richardson

PLSB Attorney Katherine Donovan reported that Lucille Richardson had been issued an Arkansas teacher license by reciprocity based upon her active licensure in Tennessee in 2006. Upon review of her application for renewal, the Department discovered Ms. Richardson's Tennessee license was revoked in September 2008 after a final order from the Tennessee Department of Children's Servicing finding her to be a perpetrator of child abuse against a thirteen-yearold autistic student.

Ms. Richardson said she was never informed her Tennessee license was revoked; and, therefore, did not falsify information on her application renewal form. She stated she had taught in the West Memphis School District for the past five years.

Mr. Ledbetter moved, seconded by Ms. Saviers, to deny Lucille Richardson's application for the renewal of her teacher license. The motion carried.

#### ADE'S PROJECT MANAGEMENT TOOL EXECUTIVE SUMMARY MARCH 31, 2011

This document summarizes the progress that ADE has made in complying with the provisions of the Implementation Plan during the month of March 2011.

#### IMPLEMENTATION PHASE ACTIVITY

#### I. Financial Obligations

- A. As of February 28, 2011, State Foundation Funding payments paid for FY 10/11 totaled \$37,189,887 to LRSD, \$22,772,267 to NLRSD, and \$28,199,412 to PCSSD.
- B. As of February 28, 2011, the Magnet Operational Charge paid for FY 10/11 totaled \$9,684,790. The allotment for FY 10/11 was \$15,051,190.
- C. As of February 28, 2011, the M-to-M incentive checks paid for FY 10/11 totaled \$2,943,114 to LRSD, \$3,593,346 to NLRSD, and \$6,286,998 to PCSSD.
- D. ADE pays districts three equal installments each year for their transportation budgets.
  - 1. In September 2010, General Finance made the last one-third payment to the Districts for their FY 09/10 transportation budget. As of September 30, 2010, transportation payments for FY 09/10 totaled \$4,054,730.00 to LRSD, \$1,471,255.67 to NLRSD, and \$2,544,356.20 to PCSSD.
  - 2. In September 2010, General Finance made the first one-third payment to the Districts for their FY 10/11 transportation budget. As of September 30, 2010, transportation payments for FY 10/11 totaled \$1,354,368.33 to LRSD, \$510,218.13 to NLRSD, and \$905,109.15 to PCSSD.
  - 3. In February 2011, General Finance made the second one-third payment to the Districts for their FY 10/11 transportation budget. As of February 28, 2011, transportation payments for FY 10/11 totaled \$2,708,736.66 to LRSD, \$1,020,436.26 to NLRSD, and \$1,810,218.30 to PCSSD.
- E. Bids were opened on May 7, 2010 for sixteen Magnet and M-to-M buses. The low bid was by Diamond State Bus Sales for a total of \$1,135,960. There are fourteen 65 passenger buses at \$71,210 per unit and two 47 passenger units at \$69,510 per unit. Little Rock will get 8 65 passenger buses. Pulaski County Special will get 4 65 passenger buses and 2 47 passenger buses. North Little Rock will get 2 65 passenger buses. In September 2010, 16 new Magnet and M-to-M buses were delivered to the districts in Pulaski County. Finance paid Diamond States Bus Sales \$1,135,960.
- F. In July 2010, Finance paid the Magnet Review Committee \$92,500. This was the total amount due for FY10/11.
- G. In July 2010, Finance paid the Office of Desegregation Monitoring \$200,000. This was the total amount due for FY 10/11.

#### II. Monitoring Compensatory Education

On January 13, 2011, the ADE Implementation Phase Working Group met to review the Implementation Phase activities for the previous quarter. Mr. Willie Morris, ADE Lead Planner for Desegregation, updated the group on all relevant desegregation issues. Mr. Mark White from ADE Legal Services said that U.S. District Judge Brian Miller is considering the information that was presented in the desegregation unitary status hearings for the North Little Rock School District and the Pulaski County Special School District. He also stated that the Little Rock School District had requested information about individual students that cannot be released because of Federal student privacy regulations. Little Rock School District Superintendent Linda Watson resigned. The Little Rock School Board chose Morris Holmes as the interim superintendent. Facility plans by the Pulaski County Special School District to close several schools caused concerns by parents in the district. The plan included closing Robinson High School and sending students to Maumelle High School. Closing College Station Elementary was also part of the plan.

#### *III. A Petition for Election for LRSD will be Supported Should a Millage be Required* Ongoing. All court pleadings are monitored monthly.

#### *IV.* Repeal Statutes and Regulations that Impede Desegregation

In July 2007, the ADE sent letters to the school districts in Pulaski County asking if there were any new laws or regulations that may impede desegregation. The districts were asked to review laws passed during the 86<sup>th</sup> Legislative Session, and any new ADE rules or regulations.

#### V. Commitment to Principles

On March 14, 2011, the Arkansas State Board of Education reviewed and approved the PMT and its executive summary for the month of February.

#### VI. Remediation

The Arkansas Department of Education (ADE) conducted a webinar on February 24, 2011, to train for administration of the English Language Development Assessment (ELDA).

The ADE conducted a webinar on February 25, 2011, to train district personnel on technology requirements for administration of the online Algebra I retest.

District test coordinator training for the administration of the spring ACTAAP exams was held on March 3, 2011 at the ADE.

#### VII. Test Validation

On February 12, 2001, the ADE Director provided the State Board of Education with a special update on desegregation activities.

#### VIII. In-Service Training

On February 18, 2011, ADE staff conducted Instructional Facilitator Training in the PCSSD Administration Building Board Room. Instructional Facilitators were taught two types of learning (mechanical and metaphorical), and the appropriate thinking device, effective questioning, collaborative learning structures to support each type of learning and the importance of aligning challenging assignments to the needs of the learners.

#### VIII. In-Service Training (Continued)

On February 22, 2011, Jim Knight Instructional Facilitating Training was conducted at Oak Grove High School in the PCSSD. The secondary instructional facilitators observed a secondary art teacher's classroom. The instructional facilitators used a questioning tool to collect data on the type, kind, and level of questions the teacher asked. After the observation, the instructional facilitators analyzed the data and made recommendations about how the teacher could improve her questioning of students.

On March 9, 2011, ADE staff facilitated professional development for Instructional Facilitators at Northwood Middle School in the PCSSD. Secondary Literacy Instructional Facilitators practiced collecting data on the use of a Learning Map while observing a 7th grade English Language Arts Class at Northwood Middle School. After the observation, the Instructional Facilitators debriefed the observation and examined the collected data.

#### IX. Recruitment of Minority Teachers

In December 2010, the ADE Office of Professional Licensure sent a request to the three Pulaski County school districts asking for a list of anticipated teacher shortage areas by grade and subject.

During the month of December 2010, the ADE Office of Professional Licensure contacted all institutions of higher education with teacher education programs requesting a listing of minority graduates for the fall of 2010.

In December 2010, the ADE Professional Licensure Unit contacted all Pulaski County school districts asking for a statement evaluating the effectiveness of ADE minority recruitment assistance.

#### X. Financial Assistance to Minority Teacher Candidates

Ms. Tara Smith of the Arkansas Department of Higher Education reported minority scholarships for Fiscal Year 2009-2010 on February 24, 2010. These included the State Teacher Assistance Resource (STAR) Program, the Minority Teacher Scholars (MTS) Program, and the Minority Masters Fellows (MMF) Program. The scholarship awards are as follows:

#### XI. Minority Recruitment of ADE Staff

The MRC met on November 3, 2010 at the ADE. A report was presented at the meeting that showed ADE employees in grades C121 to C129 by race and section for the quarter ending September 30, 2010. A graph was also presented that showed the percentage of black, white and other employees for the ADE as a whole and by division. During the quarter ending September 30, 2010, the following three groups met the Desegregation Agreement target of 25% black: Central Administration, Academic Accountability, and Research & Technology. The ADE as a whole was 21% black.

#### XII. School Construction

This goal is completed. No additional reporting is required.

#### XIII. Assist PCSSD

Goal completed as of June 1995.

#### XIV. Scattered Site Housing

This goal is completed. No additional reporting is required.

XV. Standardized Test Selection to Determine Loan Forgiveness Goal completed as of March 2001.

#### XVI. Monitor School Improvement Plans

On February 22, 2011, ADE staff held a Smart Accountability Meeting with Little Rock School District Leadership at the Geyer Springs Elementary Library. ADE staff stated that as a district starts an initiative, the evaluative measure should be known up front and the points at which it will be measured. They also mentioned that page 80 of the Arkansas Department of Education Professional Development Toolkit talks about setting measurable goals for professional development and how those goals can be written into an action plan. By using Root Cause Analysis, districts will know how to analyze the data. Then leadership team structures should be formed and put into place. Examination of Response to Intervention will look for solid core instruction and effective intervention services. The interventions being put in place in the buildings should be differentiated according to level and the subpopulation that caused the school to be placed in school improvement.

On February 25, 2011, the ADE Smart Accountability State Specialty Team met with leadership of the North Little Rock School District in the NLRSD Administration Building. ADE staff discussed the district's progress in working with their schools that are in Year 3 and beyond of School Improvement. District actions and professional development needs were examined and the most effective ways to accomplish district goals were discussed.

On February 25, 2011, the ADE Smart Accountability State Specialty Team met with PCSSD staff at the District Leadership Team Meeting at the district central office. ADE shared an example of a district that is setting intermediate goals each quarter and checking each quarter to see what adjustments need to be made to keep students on track for the ultimate goal of student achievement. The teachers share with each other their transparency of practice. They are ready to begin visiting other schools and districts to share information. Sharing successful strategies with other districts will strengthen the collaborators practices. The ADE is working to help PCSSD schools make achieving status and close the achievement gap. Goals will be achieved by supporting a data-driven leadership structure with effective communication flow, strong core Instruction and targeted Interventions. ADE staff encouraged the district to work toward a common understanding of the role of Instructional Facilitators. They also encouraged the district to set smart goals to evaluate the success of the interventions in the ACSIP Plan.

#### XVII. Data Collection

The ADE Office of Public School Academic Accountability has released the 2009 Arkansas School Performance Report (Report Card). The purpose of the Arkansas School Performance Report is to generally improve public school accountability, to provide benchmarks for measuring individual school improvement, and to empower parents and guardians of children enrolled in Arkansas public schools by providing them with the information to judge the quality of their schools. The Department of Education annually publishes a school performance report for each individual public school in the state, and distributes the report to every parent or guardian of a child in kindergarten through grade twelve (K-12) in the public schools of Arkansas.

#### XVIII. Work with the Parties and ODM to Develop Proposed Revisions to ADE's Monitoring and Reporting Obligations

On July 10, 2002, the ADE held a Desegregation Monitoring and Assistance Plan meeting for the three school districts in Pulaski County. Mr. Willie Morris, ADE Lead Planner for Desegregation, presented information on the No Child Left Behind Act of 2001. A letter from U.S. Secretary of Education, Rod Paige, was discussed. It stated that school districts that are subject to a desegregation plan are not exempt from the public school choice requirements. "If a desegregation plan forbids the school district from offering any transfer option, the school district should secure appropriate changes to the plan to permit compliance with the public school choice requirements". Schools in Arkansas have not yet been designated "Identified for Improvement". After a school has been "Identified for Improvement", it must make "adequate yearly progress". Schools that fail to meet the definition of "adequate yearly progress", for two consecutive years, must provide public school choice and supplemental education services. A court decision regarding the LRSD Unitary Status is expected soon. The LRSD and the NLRSD attended the meeting. The next meeting about the Desegregation Monitoring and Assistance Plan will be held in August, 2002, after school starts.

## Section 1 Revolving Loans to School Districts

Pursuant to Arkansas Code Annotated § 6-20-802, school districts may borrow from the Revolving Loan Program for any of the following purposes:

- (1) Funding of its legally issued and outstanding postdated warrants;
- (2) Purchase of new or used school buses or refurbishing school buses;
- (3) Payment of premiums on insurance policies covering its school buildings, facilities, and equipment in instances where the insurance coverage extends three (3) years or longer; and replacement of or payment of the district's pro rata part of the expense of employing professional appraisers as authorized by § 26-26-1901 et seq. or other laws providing for the appraisal or reappraisal and assessment of property for ad valorem tax purposes;
- (4) Making major repairs and constructing additions to existing school buildings and facilities;
- (5) Purchase of surplus buildings and equipment;
- (6) Purchase of school sites for and the cost of construction thereon of school buildings and facilities and the purchase of equipment for the buildings;
- (7) Purchase of its legally issued and outstanding commercial bonds at a discount provided that a substantial savings in gross interest charges can thus be effected;
- (8) Refunding of all or any part of its legally issued and outstanding debt, both funded and unfunded;
- (9) Purchase of equipment;
- (10) Payment of loans secured for settlement resulting from litigation against a school district;
- (11) The purchase of energy conservation measures as defined in Title 6, Chapter 20, Subchapter 4; and
- (12) (A) The maintenance and operation of the school district in an amount equal to delinquent property taxes resulting from bankruptcies or receiverships of taxpayers and for loans to school districts in an amount equal to insured facility loss or damage when the insurance claim is being litigated or arbitrated.
  - (B) For purposes of this subdivision, the loans become payable and due when the final settlement is made, and the loan limits prescribed by § 6-20-803 shall not apply.

The maximum amount a school district may borrow is \$500,000 (A. C. A. § 6-20-803). Revolving loans are limited to a term of ten (10) years (A. C. A. § 6-20-806).

#### Section 2 Second Lien Bonds

Arkansas Code Annotated § 6-20-1229 (b) states the following:

(b) All second-lien bonds issued by school districts shall have semi-annual interest payments with the first interest payment due within eight (8) months of the issuance of the second-lien bond. All second lien bonds shall be repaid on payment schedules that are either:

- (1) Equalized payments in which the annual payments are substantially equal in amount; or
- (2) Decelerated payments in which the annual payments decrease over the life of the schedule.

This firm represents the Earle School District ("District"). The District is in receipt of a letter dated February 18, 2011 from Ms. Hazel Burnett of the Arkansas Department of Education ("Department") notifying the District that it has been identified by the Department as a school district in fiscal distress pursuant to Ark. Code Ann. § 6-20-1905.

The purpose of this letter is to notify the Department of the District's appeal to the Arkansas State Board of Education ("State Board") of the notice of fiscal distress status from the Department. The District should not be classified as in fiscal distress for the following reasons:

- 1. The District does not have a declining fund balance which would jeopardize the fiscal integrity of the District;
- 2. The District has not materially failed to provide timely and accurate legally required financial reports;
- 3. The District has sufficient funds to cover payroll, salary, employment benefits and legal tax obligations;

It has been detected operationally inefficient for Little Rock School District to continue operations of the Felder Charter. If approval is provided, a new ALE program description will be completed to expand the existing Hamilton Learning Academy ALE.

The existing Felder site would house all sixth through eight grade ALE students. (150 optimum enrollment number)

The Hamilton site would house all ninth through twelfth grade ALE and Residential Treatment students. (266 optimum enrollment number)

The present Felder student population will be served within an existing LRSD ALE. Proposed modification will separate the middle and high school population.

#### **Historical Profile**

In 2005, the three Pulaski County school Districts (Little Rock, North Little Rock and Pulaski County Special School District) formed a partnership with the Pulaski County Government and the Juvenile Court to implement a Tri-District Conversion Charter School for the purpose of providing an educational setting for students, grades six through twelve, who had committed serious offenses of their district's code of conduct to the extent they needed to be removed from their regular school environment and placed in a more structured setting. The school would serve students who have been truant, have been identified as status offenders and/or have committed offenses to the extent that the Juvenile Judges have intervened and determined they need a more structured environment as the last alternative before placing them in a juvenile detention facility.

The charter proposal was approved by the local school districts' Board of Directors, submitted and approved by the State Board of Directors. Arthur "Bo" Felder Alternative Learning Academy opened in August, 2005 and was located at 8300 Geyer Springs Road with Little Rock School District serving as the LEA and therefore claiming the students for funding purposes. Felder Alternative Learning Academy was designed to provide a military-oriented environment while meeting the educational needs of adjudicated youth who have been removed from a traditional environment. The Pulaski County Government agency agreed to pay the cost of leasing the facility located at 8300 Geyer Springs Road. a de la compañía de s

In May, 2007, the Pulaski County Government notified the Tri-District partnership that it would no longer have the financial capacity to pay the leasing costs of the facility. The Tri-District partners began to search for other properties that could house the school. In July, 2007, Felder Alternative Learning Academy was relocated to the Badgett Elementary site at 6900 Pecan Lane which met all state building requirements and owned by Little Rock School District, upon receiving approval by the State Board of Education.

On January 24, 2008, the Pulaski County Special School District determined that it was not fiscally efficient for the District to continue to participate in the tri-district partnership. A letter was submitted to the state by then superintendent, James Sharpe, regarding the Pulaski County School District Board of Directors unanimous vote to discontinue participating, effective June 30, 2008. A one year renewal charter was submitted and approved by the State Board at that time for the 2008-2009 school year. The partnership requested a one year renewal so that the two school districts (Little Rock and North Little Rock school districts) would have the time to review funding and determine the financial feasibility of continuing to operate after such in light of the fact that two of the original funding sources had been discontinued since its inception.
