Assistant Commissioner Dr. Darrell Smith presented the panel with accountability profiles for nine schools with charters expiring on June 30, 2026. The Charter School Office recommended to the CAP that charters be renewed for 5 years for the following schools:

1. Cave City High School Career and Collegiate Preparatory School
2. Cave City Middle School Career and Collegiate Preparatory
3. Cross County Elementary Tech Academy
4. Cross County High School--A New Tech School
5. Fayetteville Virtual Academy--A District Conversion Charter School

6. Mountain Home High School Career Academies
7. Southside Charter High School
8. Southside Junior High School
9. Westwind School for the Performing Arts

After discussion and questions from the panel, it was moved by Dr. Tina Moore to accept the recommendation of the Charter School Office and renew all nine schools for 5 years. The motion was seconded by Ms. Edie Stewart. The motion passed unanimously.
