<ol style="list-style-type: none"> 1. 1) Upon reviewing production records for the week of October 30 to November 4, 2022, at both Woodrow Wilson and Baldwin Elementary, various errors were discovered. <ol style="list-style-type: none"> a. At breakfast on November 3, 2022, a gram cracker crediting only ¼ ounce equivalent (oz eq) of grains was the only grain served. According to 7 CFR 220.8(c), at least one (1) oz eq is required daily. b. At lunch on November 2, 2022, only ¼ cup of vegetables was served. According to 7 CFR 210.10(c), at least ¾ cup of vegetables is required daily. c. At lunch during the week of October 30 to November 4, 2022, no vegetables in the subgroup category of beans/peas (legumes) were served. According to 7 CFR 210.10(c), ½ cup of beans/peas (legumes) is required weekly.
