


CAP Minutes – February 13, 2024

- I. Meeting called to order at 9:00 am. Members in attendance are Dr. Sonja Wright-McMurray, Freddie Scott, Chair Dr. Matthew Sutherlin, Phil Baldin, Dr. Tina Moore, and CAP Chair swore in all who planned to speak.   - a. Motion to accept consent agenda. Motion by Dr. McMurray, seconded by Dr. Moore. Passed unanimously.
- II. Action Agenda.
  - a. Stephen Reynolds, ADE Legal gave a presentation on procedures for the Charter Authorization (CAP) meeting.
  - b. Dorie Summons, Director of Charter Schools for ADE presented Bentonville School for Advanced Studies (BSAS) Amendment Request.
    - i. BSAS requested that their name be changed to School for Advanced Studies Northwest Arkansas.
    - ii. BSAS also requested a waiver to be allowed to have virtual board meetings and be allowed to meet quarterly.
    - iii. Dr. Moore moved to approve both requests. Dr. McMurray seconded. Passed unanimously.
  - c. Pulaski County Special School District Charter Recission for their Drive Virtual Academy.
    - i. Dorie Summons introduced the letter from the district asking that the charter be rescinded.
    - ii. Mr. Baldwin moved to accept. Mr. Scott seconded.
    - iii. Motion passed unanimously.
  - d. Batesville High School Charter Amendment Request.
    - i. Dorie Summons introduced. School requested a waiver for class size, teaching load, flexible schedule, teacher licensure, gifted and talented, and library media specialist.
    - ii. Jennifer Douglas, superintendent, presented on behalf of the school.
    - iii. Stephen Reynolds had no issue with any of the requested waivers during legal review.
    - iv. Mr. Baldwin moved to approve request. Dr. Moore seconded.
    - v. Motion passed unanimously.
  - e. Charter Performance data.
    - i. Tiffani Grayer and Jeffery Fetters from ADE Public School Accountability presented to the CAP.
    - ii. Dr. McMurray questioned by certain charter schools were exempt from receiving accountability letter grades. Ms. Grayer responded that this was due to the law surrounding the type of schools they were.
