Findings: 1. After reviewing the SFA's Wellness documents for the school year 2022-2023, a couple of issues were found:				

- a. The wellness committee did not meet regularly for the school year 22-23, because of those missed meetings, the menus were not reviewed quarterly for the school year. According to A.C.A. § 6-20-709, menus must be reviewed and provided to the school nutrition and physical activity advisory committee on a quarterly basis.
- b. SFA was unable to provide documentation of Triennial Assessment. According to 7 CFR 210.31(f), district must retain records showing compliance with wellness requirements including triennial assessment, updates to the local wellness policy, and demonstrating policy, assessments, and goals are made available to the public.
