These counts were then entered into the districts point of sale software system prior to the meal service. In accordance with 7 CFR 210.7(c)(1)(iii) the Claim for Reimbursement accurately reflects the number of lunches, taken daily at the point of service, which correctly identify the number of free, reduced price and paid lunches served to eligible children.

1) Upon review of December 2021 menus it was discovered that preschool students were served grain based desserts on two (2) of the thirteen days (13). In accordance with 7 CFR 226.20, Child and Adult Care Food Program (CACFP) meal pattern states that no grain based desserts may be credited toward the grain component of the meal pattern. It was also discovered that preschool students were served a breakfast cereal, which contained 7 grams of sugar per dry ounce. In accordance with 7 CFR 226.20(a)(4)(ii) Breakfast cereals must contain no more than 6 grams of sugar per dry ounce.
