The Arkansas State Board of Education (State Board) met Thursday, June 8, 2023.
Ms. Ouida Newton called the meeting to order at 9:31 AM, followed by a moment of silence.

Item III.1. was presented by Ms. Karli Saracini, ADE Assistant Commissioner, Educator Effectiveness & Licensure. Present was Ms. Emily Howard, 2022 Milken Award winner.

Ms. Emily Howard, third grade teacher at Drew Central School District, Monticello, Arkansas, was recognized as the Milken Award winner, sponsored by the Milken Foundation.

III.2. Stagecoach Elementary Robotics Team (Jessica House, Teacher)

Item III.2. was presented by Ms. Jessica Saum, 2022 Arkansas Teacher of the Year. Present were the Stagecoach Elementary Robotics team Magnolia Saum, Lily Perkins, Blaine Tierney, Aliya White, and Ainsley Wood and their coach, Ms. Jessica House. Also present were their sponsors Ms. Cooper, Ms. Cartwright (absent), their principal Ms. Carol Skiba, and Dr. Tony Thurman, Superintendent, Cabot School District.

The all-girl team qualified at the regional tournament, making it to state where they won the Design Award, making it to the Worlds competition in Dallas, TX where 800 teams competed, of which four teams were from Arkansas.

Report – Alternative Learning Education Long-Term Subs in Arch Ford Cooperative Region

The report on alternative learning education (ALE) long-term subs in the Arch Ford Education Cooperation region was presented by Ms. Karli Saracini, ADE Assistant Commissioner, Educator Effectiveness & Licensure, Ms. Deborah Coffman, ADE Assistant Commissioner, Public School Accountability, and Dr. Ivy Pfeffer, ADE Deputy Commissioner.

At the State Board meeting held May 11, the State Board requested the Division of Elementary and Secondary Education (DESE) to research and report findings on long-term subs in the Arch Ford Education Service Cooperative at the State Board meeting scheduled June 8. Ms. Saracini reported that after researching the issue of ALE long-term subs, standard operating procedures are being put into place to correct this issue in the future. Furthermore, Licensure is researching each waiver to ensure students have qualified teachers. The ALE issue is still being worked on and Matt Sewell, ADE Director, Special Programs/Special Education and his team will report to the State Board. Licensure is not granting long-term subs for ALE; they have essentially been denied. DESE will communicate with Ms. Audie Alumbaugh, who initially brought the issues to the attention of the State Board. Additionally, Licensure will begin to submit to the State Board current waivers compared to last-year waivers. Also, the State Board would like to see from Licensure, the State average number and grand total of alternative licensing plans in Arkansas to look at the statewide picture, to include districts statewide that have 1240 waivers through the Office of Public School Accountability by statewide, co-op region, down to district level.


