1. Call to Order – Dr. Donny Lee – Chair

Dr. Donny Lee called the meeting to order at 9:00 a.m.

2. Approval of Minutes

Dudley Webb III made a motion to approve December 6, 2024 PLSB Full Board minutes; seconded by Dr. Karen Lasker. None opposed. Motion passed.

3. Welcome to new board member Dr. Charlotte White-Wright

Presenter: Dr. Donny Lee, Chair

Dr. Donny Lee welcomed Dr. Charlotte White-Wright, Dean of the Teachers' College at Henderson State University, as the PLSB's newest board member.

4. Action Items

a. Lead Teacher Pathway Designation Approval

i. Bailey Education Group

Presenter: Dr. Matthew Sutherlin, Director of Educator Preparation and Licensure

Dr. Matthew Sutherlin gave a presentation on the review the Office of Educator Effectiveness and Licensure's review of the Bailey Education Group (BEG) as a potential Master/Lead Professional Designation pathway. The BEG application scored a 4.2 out of 5, which moved the application to the Teacher/Leader Advisory Group (TLAG) for an additional review, where it scored a 4.7 out of 5 from five of the TLAG members. Several teachers reported that had they not already achieved their designation, they would've chosen BEG as their preferred pathway. BEG currently provides professional development, coaching, and support to several schools and districts in Arkansas, in Louisiana, Alabama, Mississippi, and Florida. Both review groups view BEG as an

excellent addition to the Master Lead Professional Designation Pathways.

Dr. Sutherlin asked the board to approve the Bailey Education Group as a Master/Lead designation pathway.

Luke Lovins made a motion to approve the Bailey Education Group as a Master/Lead designation pathway; Dr. Kimberley Davis seconded the motion. None opposed. Motion passed.

j. Ethics Hearing Subcommittee – Proposed New Members
