Upon completion of the USDA Meal Certification Worksheets for the week of December 6-10, 2021, the following was discovered: <ul style="list-style-type: none"> • For the week of review, only ½ cup of the vegetable subgroup other was served. The 9-12 weekly lunch meal pattern minimum requirement for the vegetable subgroup other is ¾ cup/week (7 CFR 210.10(c)). • On December 10th, the grain component served consisted of non-whole grain rich macaroni. All grains offered weekly must be whole grain rich (7 CFR 210.10(c)). However, CNU has allowed districts to credit two non-whole grain rich items toward the grain component.
