### Informational Update on Common Core State Standards and PARCC

Dr. Laura Bednar, Assistant Commissioner of Learning Services, said the key to the successful implementation of the Common Core State Standards (CCSS) was quality professional development at all levels. She expressed appreciation to Deborah Coffman for her work on the CCSS strategic plan focused on professional learning. Dr. Bednar acknowledged Melody Morgan and the assessment staff for their teamwork in running the statewide assessment program.

Noting the PARCC assessments will be delivered online in 2014-2015, Dr. Bednar said 54 percent of the state's school districts had completed the technology readiness tool designed to give a paicture of readiness for the online tests.

Board members expressed a desire to see more districts complete the survey in preparation for the testing.

#### Hearing on Waiver Request for Certified Teacher License - Ryan Gore

Katherine Donoven, Professional Licensure Standards Board attorney, said Ryan Gore, a MAT applicant for a provisional license, was convicted of a disqualifying offense for licensing in 1999. Mr. Gore requested a waiver of the disqualifying conviction.

Ms. Saviers moved, seconded by Ms. Newton, approval of the waiver with the stipulation of probation for a period of two years and no other disqualifying conviction or violation of code of ethics. The motion carried unanimously.

## Consideration for Final Approval: Arkansas Department of Education Rules Governing Special Education and Related Services

The State Board of Education released the proposed rules for public comment July 9, 2012. A public hearing was held November 30, 2012. The public comment period expired December 3, 2012. Department staff did not receive public comments on the proposed rules but did revise the rules based upon further review of applicable state statutes. The State Board was requested to give final approval to the proposed rules.

Mr. Ledbetter pointed out that acronyms should be spelled out the first time used.

Dr. Barth moved, seconded by Ms. Reith, final approval with the writing modifications. The motion carried unanimously.

## Consideration for Final Approval: Proposed Arkansas Department of Education Rules Governing Positive Youth Development Grants

The State Board approved and released these proposed rules for public comment October 8, 2012. A public hearing was held October 25 and several comments and questions were received. No written comments were received. The State Board was requested to give final approval to the proposed rules.

Ms. Gullett moved, seconded by Dr. Barth, final approval. The motion carried unanimously.

Chairman Cooper announced that Ms. Saviers and Ms. Newton would join him as members of the nominations committee to recommend a slate of officers for 2013-2014. The committee will report at the May meeting.

Commissioner Kimbrell said the only way to make change would be through legislation. He said 280 seniors had not met the Algebra I high stakes requirement for graduation, but had two more opportunities to take the test.

Board members asked for a report at the next board meeting of the demographics of those seniors who had not passed the Algebra I test.
