# REQUEST FOR ORDER TO CLOSE ISOLATE SCHOOL

On October 9, 2025, during a regular meeting of the Arkansas State Board of Education ("State Board"), a hearing was conducted pursuant to the legal authority and jurisdiction vested in the State Board by Arkansas Code Annotated § 6-20-602, and the Arkansas Department of Education's Rules Governing the Closure of Isolated Schools, codified as 6 CAR § 233-101, et seq. The State Board considered a petition of the Ozark Mountain School District ("Petitioner") to close its Bruno-Pyatt campus, and to transfer the students attending school at the Bruno-Pyatt campus to other campuses located within the school district.

### **FINDINGS OF FACT**

From the evidence introduced at said hearing, the State Board finds that:

- 1. The Ozark Mountain School District school district is located in Searcy, Marion, and Newton Counties, Arkansas.
- 2. There are three campuses at which students located within the school district attend school: Bruno-Pyatt, Western Grove, and St. Joe.
- 3. For the current school year, there are only 14 students in grades first through fourth who attend school at the Bruno-Pyatt campus.
- 4. High School students in Bruno-Pyatt already attend grades seven through twelve at either the Western Grove or St. Joe campuses.

- 5. For the current school year, there are only two certified teachers employed at the Bruno-Pyatt campus.
- 6. On August 6, 2025, by majority vote (6-1), Petitioner's Board of Directors voted to close the Bruno-Pyatt campus and to relocate the students who attend school at the Bruno-Pyatt campus to the Western Grove and St. Joe campuses.
- 7. The cost of operating the Bruno-Pyatt campus is projected to be \$630,378.26 for the current school year which is approximately \$45,027.02 per pupil, well over the per pupil state analysis.
- 8. Norman Hill, a well-respected financial advisor to school districts, prepared a financial analysis based on 17 students enrolled in the district, that shows substantial financial loss for the current school year.
- 9. Petitioner plans to transfer ten students to the St. Joe campus, located 17 miles away from the Bruno-Pyatt campus, and four students to the Western Grove campus, located 12 miles away from the Bruno-Pyatt campus.
  - 10. Petitioner stated that it will ensure that siblings will remain together if requested.
- 11. Petitioner plans to transfer the two certified teachers employed at the Bruno-Pyatt campus to another campus in the district.
- 12. Petitioner has a transportation plan for the students who currently attend school at the Bruno-Pyatt campus.

## **CONCLUSIONS OF LAW**

13. The Bruno-Pyatt Campus is an "isolated school" as defined by Ark. Code Ann. § 6-20-601.

14. Because a majority of Petitioner's Board of Directors voted to close its Bruno-Pyatt Campus, but that vote was not unanimous, Ark. Code Ann. § 6-20-602(b) requires approval of the State Board for the closure of the Bruno-Pyatt campus.

15. Pursuant to Ark. Code Ann. § 6-20-602(b)(2)(C), the State Board finds that the closure Bruno-Pyatt Campus is in the best interest of the students in the school district as a whole, and that the closure would have no negative impact on desegregation efforts or violate a valid court order.

#### **ORDER**

Based on the Findings of Fact and Conclusions of Law above, the State Board hereby **GRANTS** Petitioner's request to close the Bruno-Pyatt campus and to transfer the students attending school at the Bruno-Pyatt campus to other campuses located within the school district. This Order shall be effective from and after October 14, 2025.
