

In addition to the Arkansas Teaching Standards, the teacher of Special Education Resource in grades K-6, 7-12 shall meet the expectations set by the following competencies. This set of competencies does not include Gifted Education or Early Intervention in Early Childhood as each of these areas has a separate set of competencies. The competencies are focused on preparing special educators who will work with students in kindergarten through 12th grade. Mastery level competencies specify what teachers should know and be able to do as a result of the completion of an educator preparation program of study. Awareness level competencies indicate that a teacher can perform the competency at its most basic level, or as much as necessary, as a result of the completion of an educator preparation program of study. Special Education Resource teachers must hold a standard Elementary Education (K-6) or middle school 4-8, or secondary 7-12 license in a content area of English Language Arts, Mathematics, or Science, successfully complete the approved program of study and pass the appropriate content licensure exam.
