The Arkansas State Board of Education (State Board) met Wednesday, December 9, 2021, in the Arkansas Department of Education (ADE) Auditorium. Chair Ouida Newton, called the meeting to order at 10:02 AM, led by a moment of silence.

Proclamation

Presented by Mr. Dan Jordan, Director, Arkansas School Board Association of Governmental Relations, the State Board recognizes and salutes the members of the local boards of education by proclaiming and recognizing the month of January 2022, as Arkansas School Board Member Recognition Month.

2022 Arkansas Superintendent of the Year Award

Represented by Dr. Mike Hernandez, Executive Director, Arkansas Association of Educational Administrators (AAEA), the AAEA, along with former Superintendents of the Year, surprised Mr. John "Skipper" Ward, Superintendent, Magnolia School District on September 13 at the Magnolia School District board meeting, with the presentation of the 2022 Arkansas Superintendent of the Year Award.

Arkansas's National Blue Ribbon Schools

Ms. Chante'le Williams, Public School Program Coordinator, Division of Elementary & Secondary Education (DESE), Office of Public School Accountability, presented plaques to Arkansas's National Blue Ribbon Schools. The National Blue Ribbon Schools award affirms the hard work of educators, families, and communities in creating safe and welcoming schools, where students master challenging and engaging content. The U.S. Department of Education (USDoE) invites National Blue Ribbon School nominations from the top education officials in all states, the District of Columbia, Puerto Rico, the Virgin Islands, the Department of Defense Education Activity, and the Bureau of Indian Education; private schools are nominated by the Council for American Private Education. Currently in its 39th year, the USDoE recognizes all schools in one of two performance categories, based on all student scores, student subgroup scores, and graduation rates:

- *Exemplary High Performing Schools* - schools that are among the state's highest performing schools, as measured by state assessments or nationally-normed tests; and,
- *Exemplary Achievement Gap Closing Schools* – schools among their state's highest performing in closing achievement gaps between a school's student groups and all students.

Up to 420 schools may be nominated each year. This year, the U.S. Secretary of Education recognized 325 schools on academic progress or closing the achievement gap, four of which were schools in Arkansas.

VI.1. Consideration of Requests for Act 1240 Waivers

Pursuant to Ark. Code Ann. § 6-15-103 (Act 1240 of 2015), a traditional public school may petition the State Board for waivers granted to an open-enrollment public charter school. Ms. Lori Freno, DESE General Counsel, presented two Act 1240 Waivers to the State Board for consideration.

VI.1.a. Fayetteville School District Act 1240 Waiver Request

The Fayetteville School District requests an Act 1240 waiver for three years of teaching load, for grades 5-12, for several of the Fayetteville School District's schools to implement a teacher intern program. Ms. Mary Claire Hyatt, General Counsel, Fayetteville School District, presented on behalf of Fayetteville School District stating the mentor teacher program is voluntary for any teacher who wants to participate, is deemed ready by their teacher prep program, and vetted by the school district. Ms. Hyatt advised that the teacher load only applies for teacher interns. Questions were presented by the Board and answered by Ms. Hyatt.

A motion to approve the Act 1240 Waiver request for Fayetteville School District was made by Ms. Charisse Dean, seconded by Dr. Beth Anne Rankin. The motion passed unanimously.

VI.1.b. Act 1240 Waiver Requests of School Districts within the Southeast Education Service Cooperative

Dr. Ivy Pfeffer, DESE Deputy Commissioner and Ms. Lori Freno, DESE General Council presented Item VI.1.b. The 15 school districts, contained within the Southeast Arkansas Educational Service Cooperative (SE ESC) region, request Act 1240 waivers for teacher licensure for five years and for library media specialist licensure for three years. DESE supports the Act 1240 waiver for teacher licensure for a period of three years. Ms. Karen Eoff, Executive Director, SE ESC, in attendance via ZOOM, presented. School district superintendents from the SE ESC region, present or attended via ZOOM, provided presentations of support for the Act 1240 waiver request for five years for teacher licensure and answered questions from the State Board.

As there will be a monitoring process for plans, after review, Dr. Pfeffer will provide the State Board with an update report on the SE ESC region schools' progress.

A motion was made by Dr. Fitz Hill and seconded by Dr. Beth Anne Rankin to approve the Act 1240 waiver requests for five years for both teacher licensure and library media specialist licensure for school districts contained within the Southeast Education Service Cooperative region. The motion passed unanimously.
