This Professional Licensure Standards Board (PLSB) matter was remanded for reconsideration of the existing record only pursuant to the order of the Circuit Court of Cleburne County issued on January 6, 2026.

A motion to find that the Danny Marrs, Jr., educator, violated Standards 1, 2, and 3 of the Arkansas Code of Ethics was made by Dr. Gary Arnold, seconded by Lisa Hunter. After roll call, the motion unanimously passed.


